DESCRIPTION


This configurable multiple-function gate is designed for 1.65-V to 5.5-V V_{CC} operation.

The SN74LVC1G97 device features configurable multiple functions. The output state is determined by eight patterns of 3-bit input. The user can choose the logic functions MUX, AND, OR, NAND, NOR, inverter, and noninverter. All inputs can be connected to V_{CC} or GND.

This device functions as an independent gate, but because of Schmitt action, it may have different input threshold levels for positive-going (V_{T+}) and negativegoing (V_{T-}) signals.

NanoFree $^{\text{TM}}$ package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using $I_{\rm off}$. The $I_{\rm off}$ circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.






Figure 1. 2-to-1 Data Selector

Figure 2. 2-Input AND Gate




Figure 3. 2-Input OR Gate With One Inverted Input 2-Input NAND Gate With One Inverted Input

Figure 4. 2-Input AND Gate With One Inverted Input 2-Input NOR Gate With One Inverted Input




Figure 5. 2-Input OR Gate

Figure 6. Inverter




Figure 7. Noninverted Buffer








