Description

The FAN156 has a complementary push-pull P- and N-channel output stage capable of driving a rail-to-rail output swing with a load ranging up to 5.0 mA.

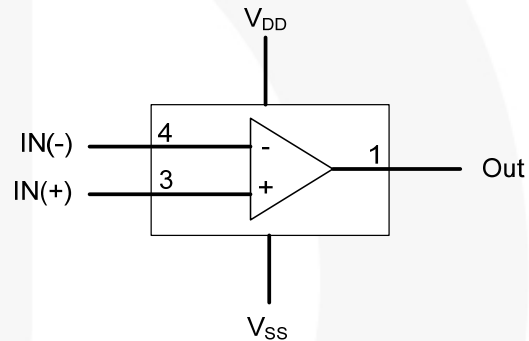


Figure 1. Functional Diagram

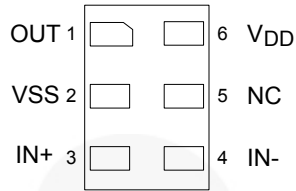


Figure 2. Pin Configuration (Top-Through View)

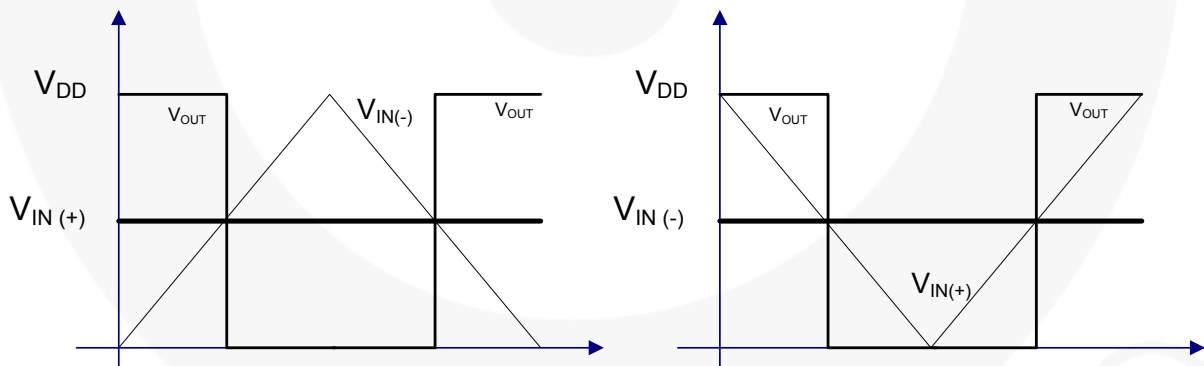


Figure 3. V_{IN} vs. V_{OUT}

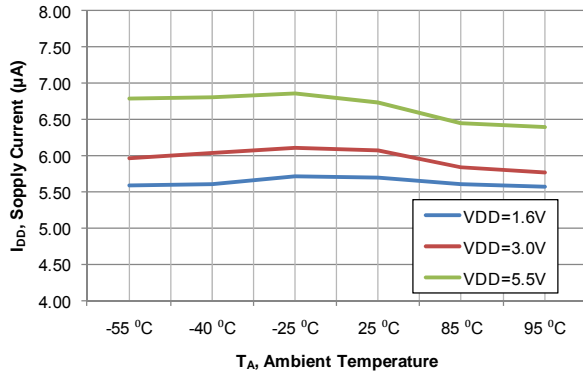


Figure 4. Supply Current vs. Temperature

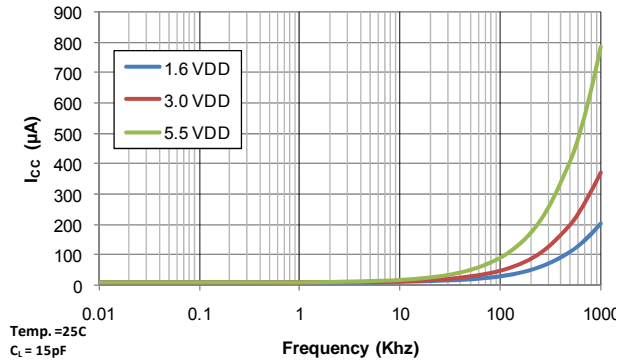


Figure 5. Supply Current vs. Output Transition Frequency

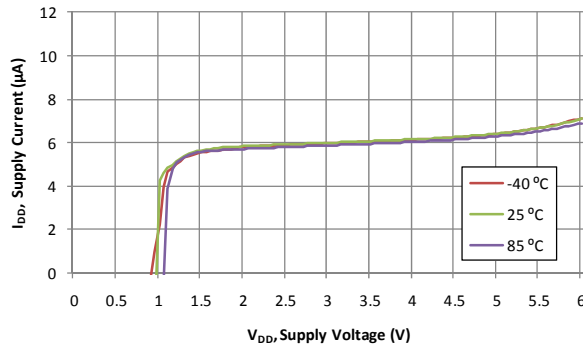


Figure 6. Supply Current vs. Supply Voltage

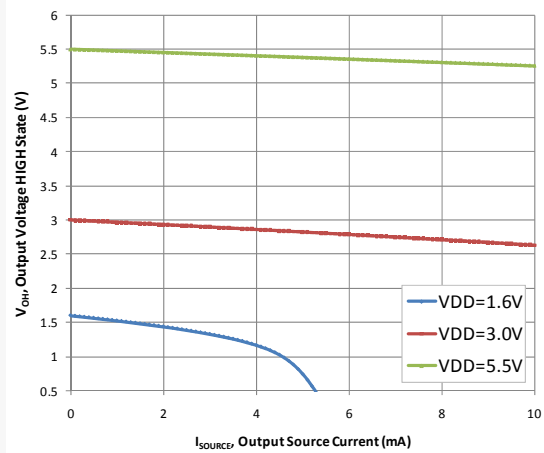


Figure 7. Output HIGH vs. Output Drive Current

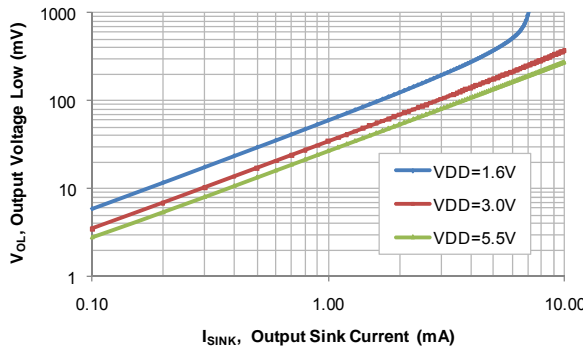


Figure 8. Output LOW vs. Output Drive Current

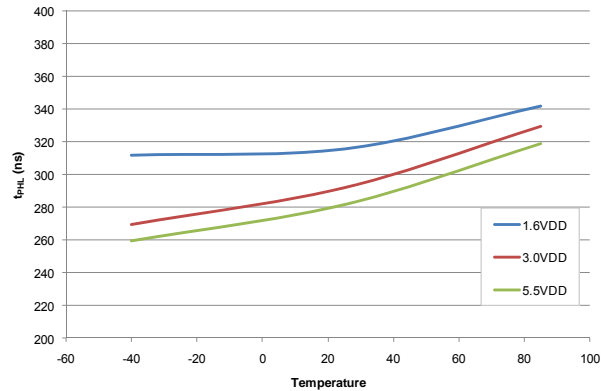


Figure 9. Propagation Delay (t_{PHL}) vs. Temperature

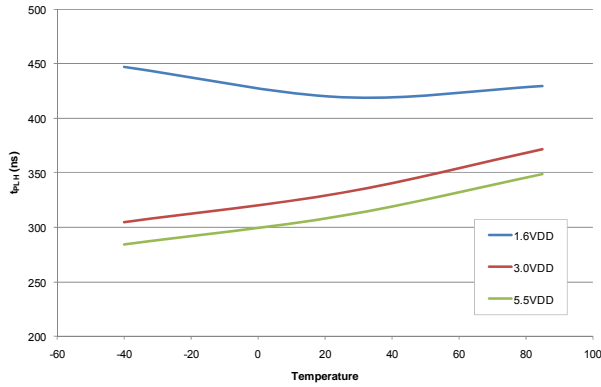


Figure 10. Propagation Delay (t_{PLH}) vs. Temperature

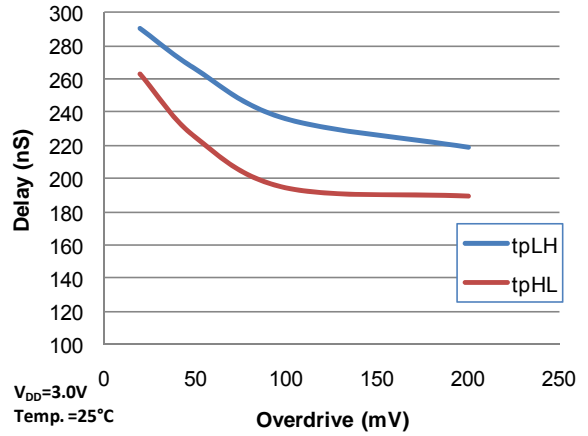


Figure 11. Propagation Delay vs. Input Overdrive

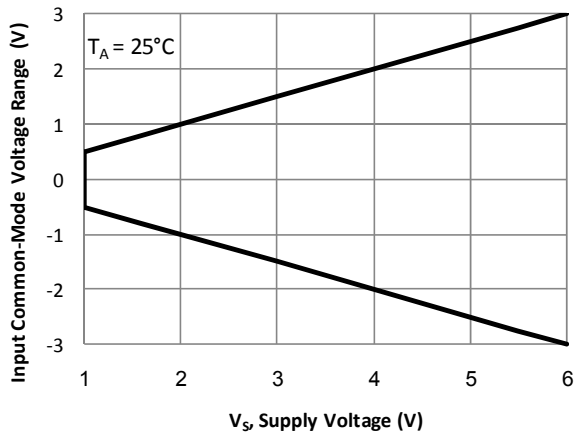


Figure 12. Input Common-Mode Voltage Range vs. Supply Voltage

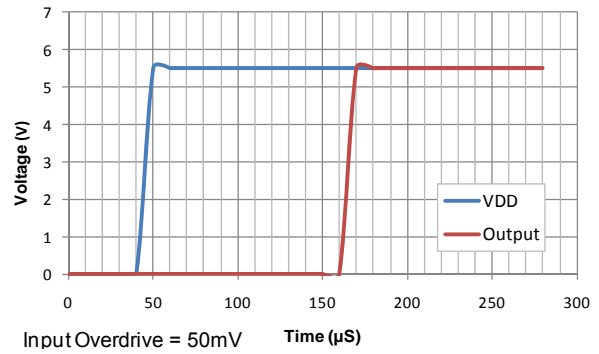
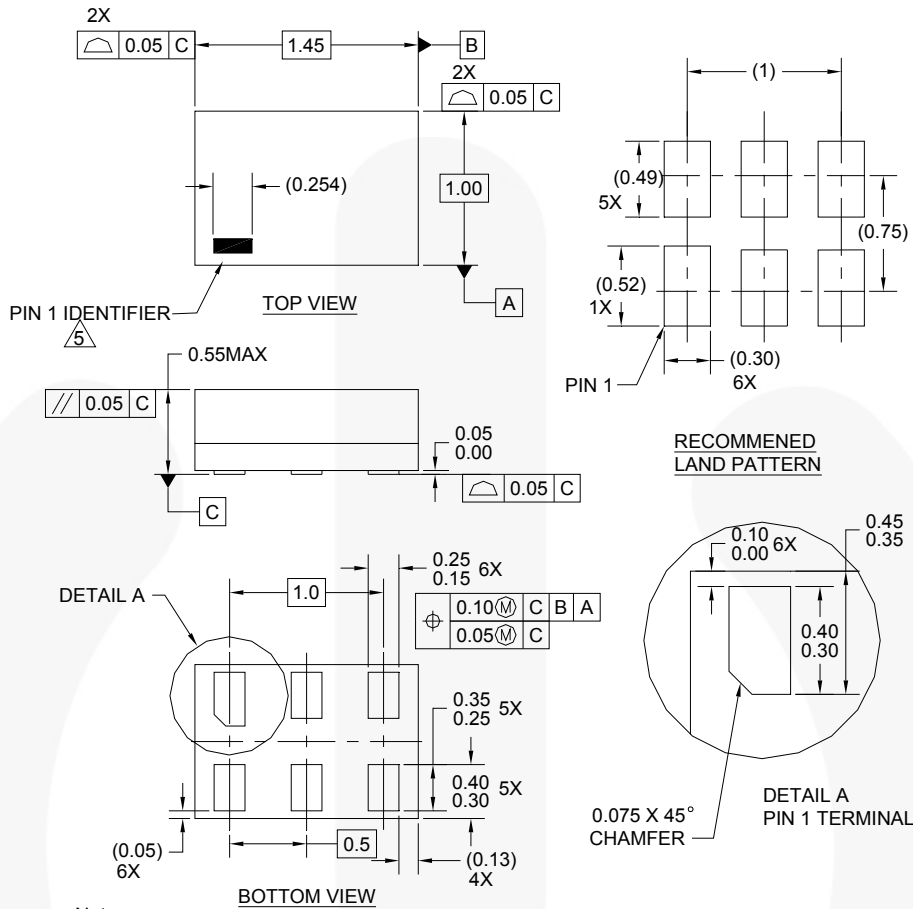


Figure 13. Power-Up Delay
