




On-Resistance vs. Drain Current




Gate Charge






On-Resistance vs. Junction Temperature




On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient

Threshold Voltage






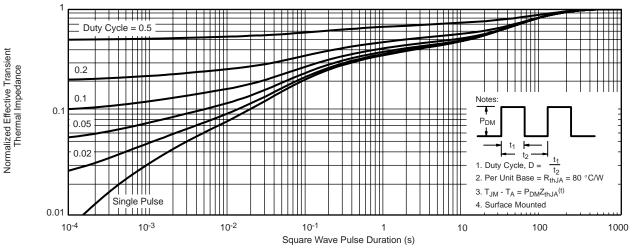





Normalized Effective Transient Thermal Impedance
