







T_J - Temperature (°C) Threshold Voltage



On-Resistance vs. Gate-to Source Voltage









Drain Source Breakdown vs. Junction Temperature




Safe Operating Area

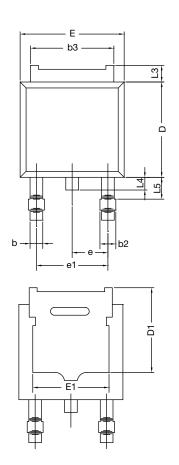




