






Source-Drain Diode Forward Voltage



Single Pulse Power, Junction-to-Ambient







Current Derating*








T_A - Ambient Temperature (°C) **Power Derating, Junction-to-Foot**



TYPICAL CHARACTERISTICS 25 C, unless otherwise noted




Normalized Thermal Transient Impedance, Junction-to-Ambient

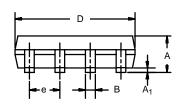


Normalized Thermal Transient Impedance, Junction-to-Foot


