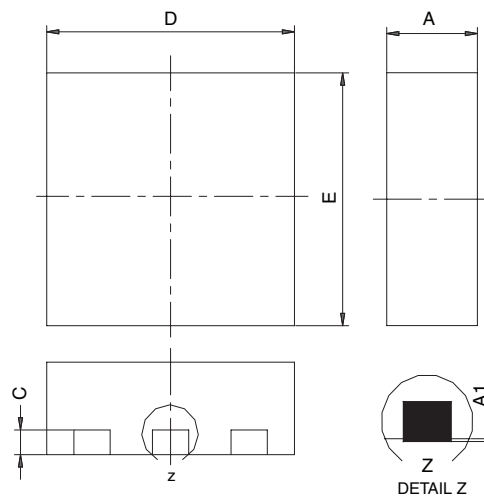

BACKSIDE VIEW OF DUAL



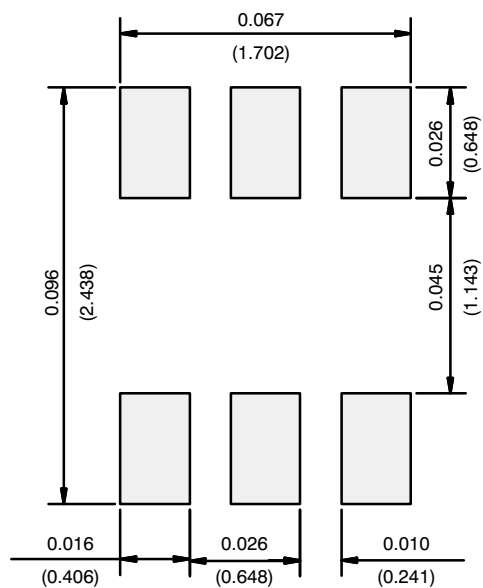
