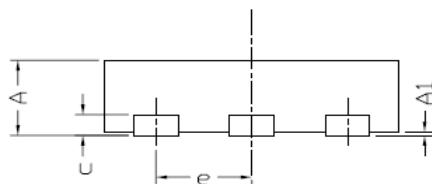

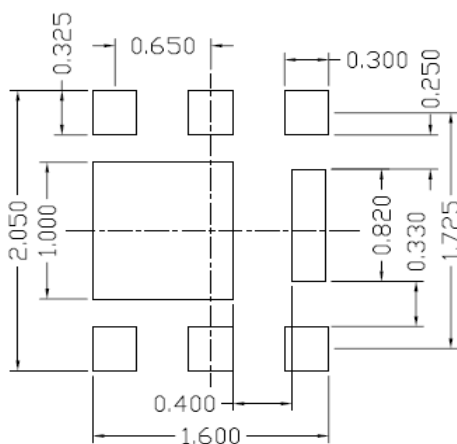
DFN2x2 _6L_EP1_S PACKAGE OUTLINE

RECOMMENDED LAND PATTERN



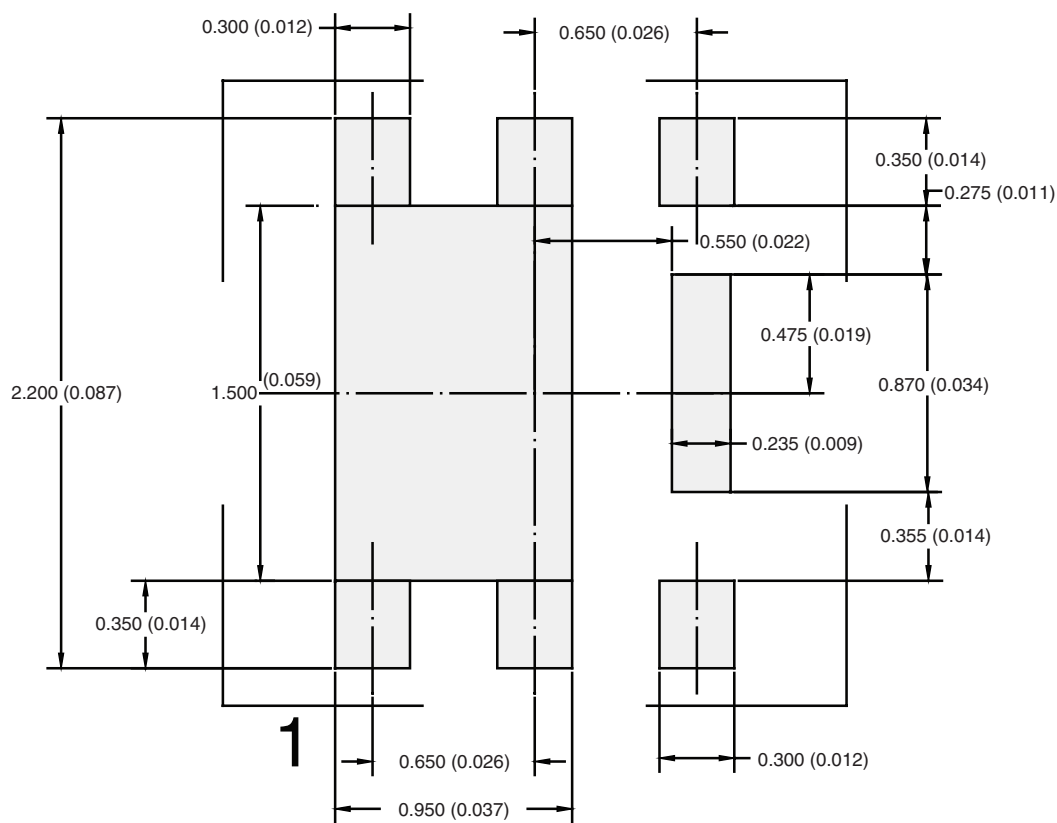
