













### On-Resistance vs. Junction Temperature





On-Resistance vs. Gate-to-Source Voltage








## Threshold Voltage Variance vs. Temperature





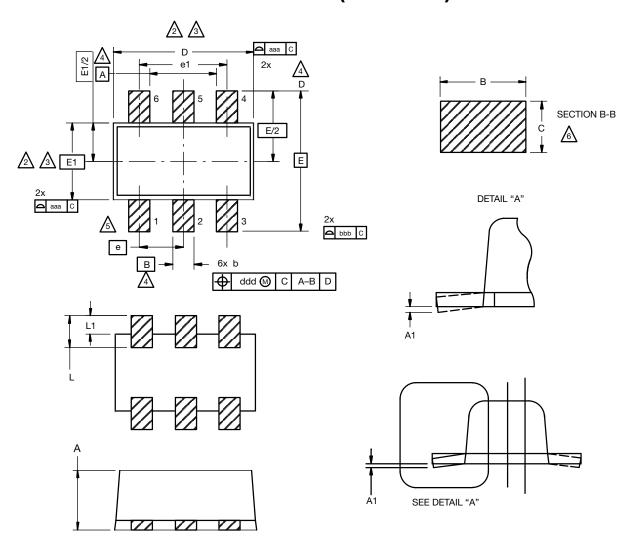

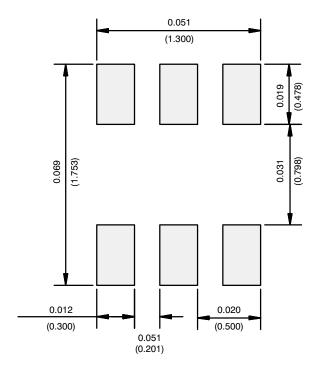
