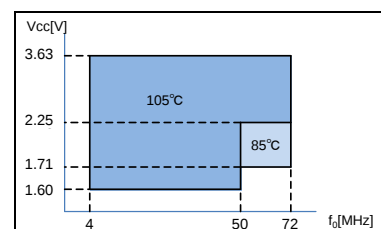


Figure 1 : The upper limit of Operating temperature and the related conditions
