

5.1、Visual inspection 外观检查

There shall be no such defect as distortion, flaw, and leakage, which may adversely affect commercial value of the battery.



- 8.1 Prohibition of battery immersion into liquid such as water; The battery shall never be soaked with liquids such as water, seawater, drinks such as soft drinks, juices, coffee or others.

- 8.2 Prohibition of dumping of batteries into fire; Never incinerate nor dispose the batteries in fire. These may cause firing of the batteries, which is very dangerous and is prohibited.

- 8.3 Dot not insert batteries in reverse. Observe the + and markings on battery and equipment.

- 8.4 \ Do not short-circuit batteries \, When the positive(+) and negative(-) terminals of a battery are connected directly with each other, the battery becomes short-circuited. This can result in venting, leakage, and possibly fire.

- 8.5 Prohibition of disassembly Never disassemble the batteries, The disassembling may generate internal short circuit in the battery, which may cause firing, or other problems.

- 8.6 Lectrolyte is harmful in case the electrolyte come into contact with the skin, or eyes, physicians shall flush the electrolyte immediately with fresh water and medical advice is to be sought.

- 8.9 Do not allow children to replace batteries without adult supervision. Keep batteries out of the reach of children. In case of ingestion of a battery, seek medical assistance promptly.

The batteries with a smell of the electrolyte or a leakage shall be placed away from fire to avoid firing.
