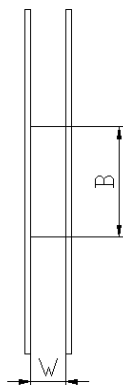
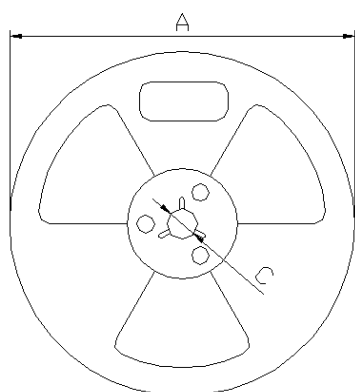

### 1) 载带包装示意图 Tape packing diagram



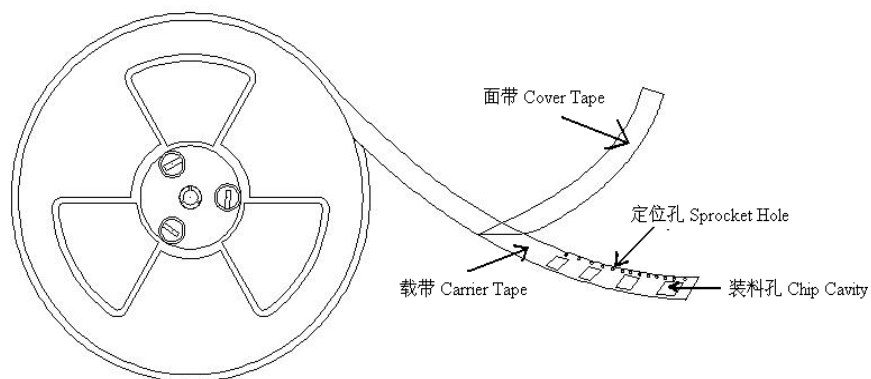
