

Device Schematic







Figure 1 Power Derating Curve




Figure 2 Pulse Derating Curve




Figure 3 Pulse Waveform




Figure 4 Typical Junction Capacitance




Figure 5 Clamping Voltage Characteristic





Figure 6 TLP Curve ($t_p = 100\text{ns}$)


