## **General Description**

The AOZ8S204BLS-24 is a single channel transient voltage suppressor designed to protect high speed data lines and voltage sensitive electronics from high transient conditions and ESD.

The AOZ8S204BLS-24 comes in an RoHS compliant package and is rated over a -40°C to +125°C ambient temperature range.

The ultra-small 0.6 mm x 0.3 mm 0201 footprint package makes the AOZ8S204BLS-24 ideal for applications where PCB space is a premium. The small size and high ESD protection makes it ideal for protecting voltage sensitive electronics from high transient conditions and ESD.










# **Typical Performance Characteristics**






### **USB3.2 Gen2 Eye Diagram (10 Gbps)**




**HDMI2.1 Eye Diagram (12 Gbps)**
