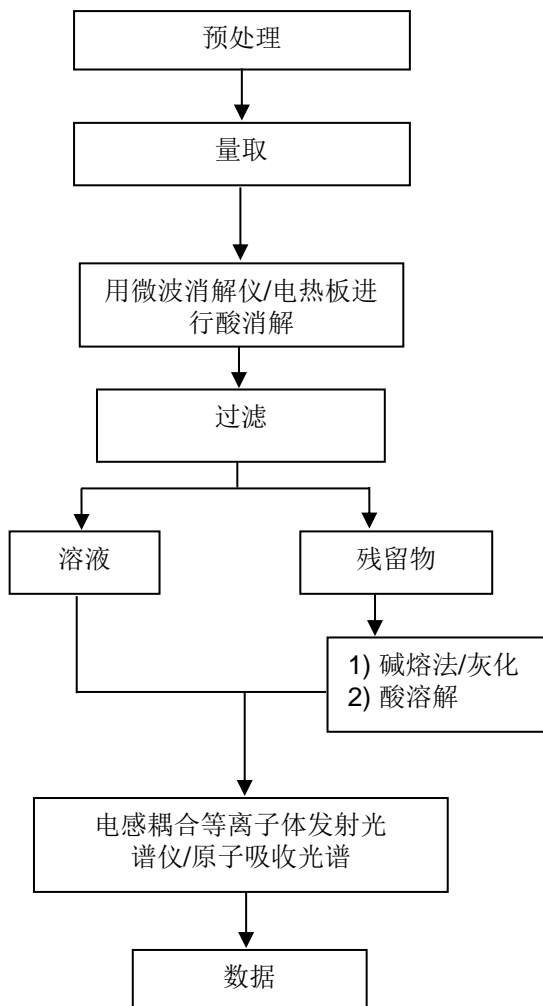

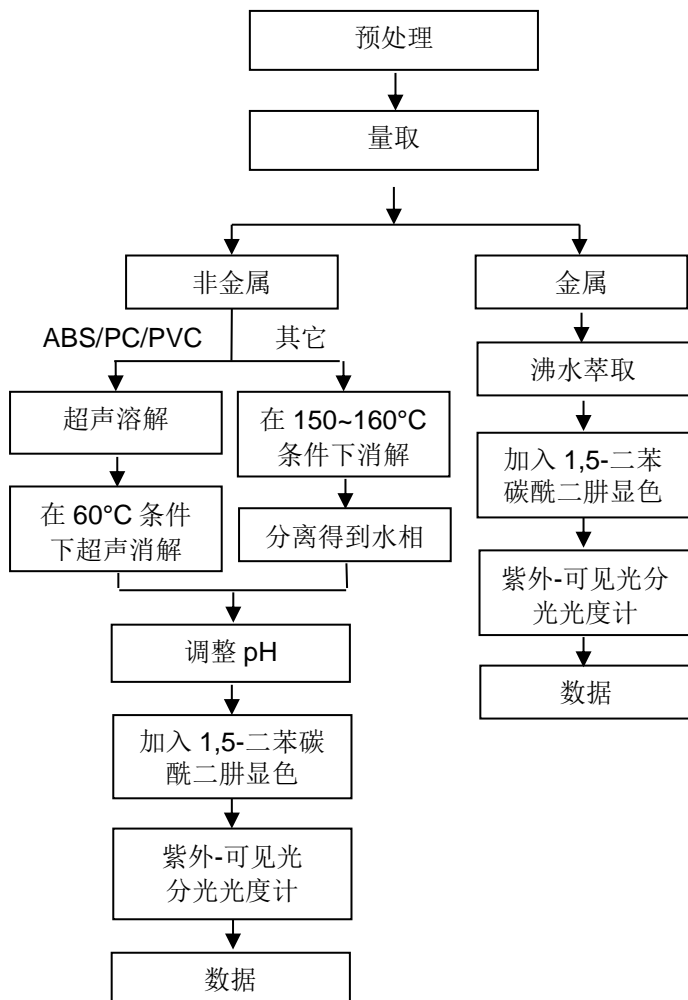

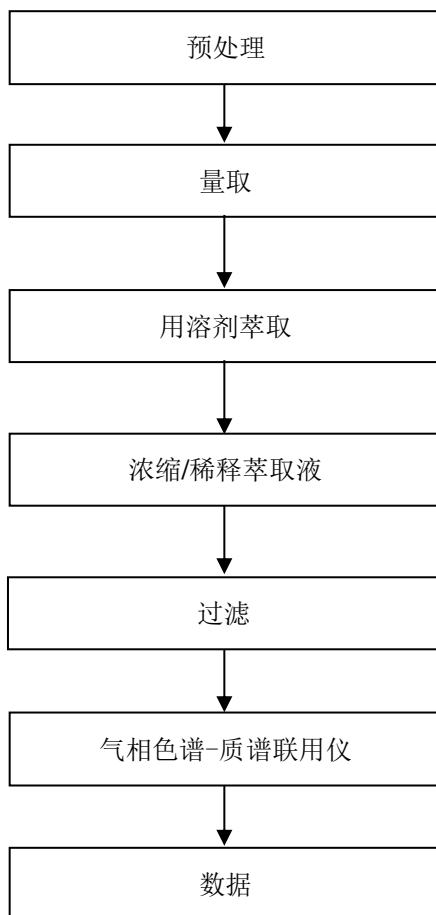

PBBs/PBDEs 检测流程图



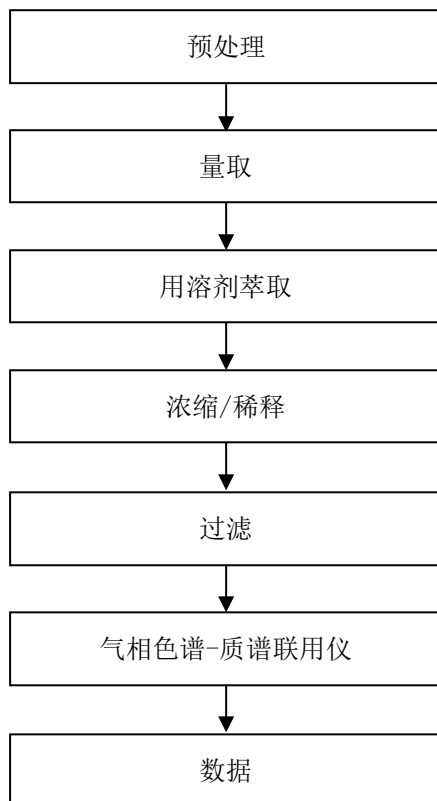

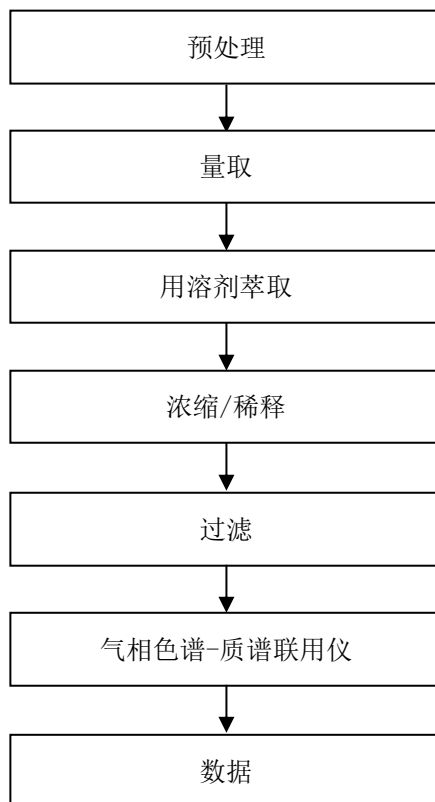

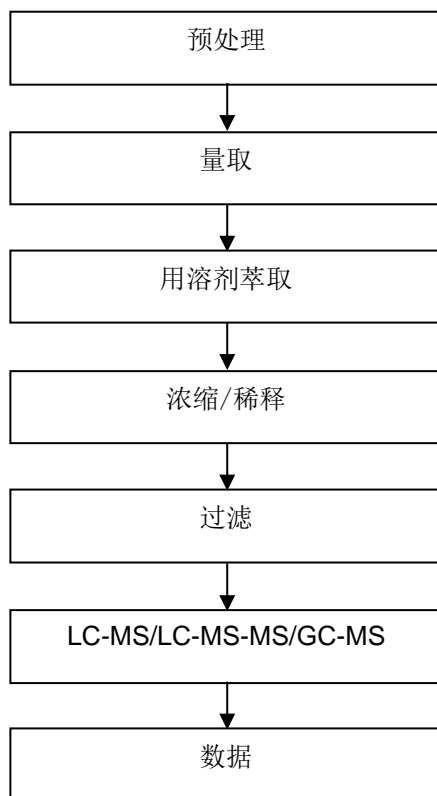
Phthalates 检测流程图

PFASs/ PFOS/PFOA 检测流程图



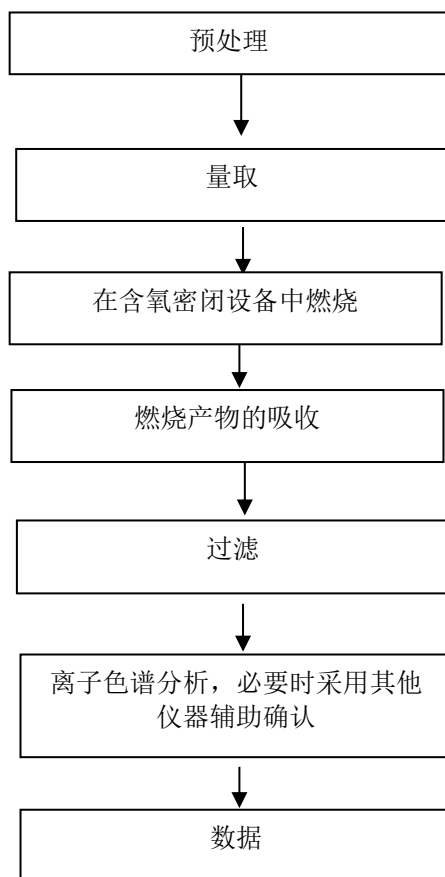

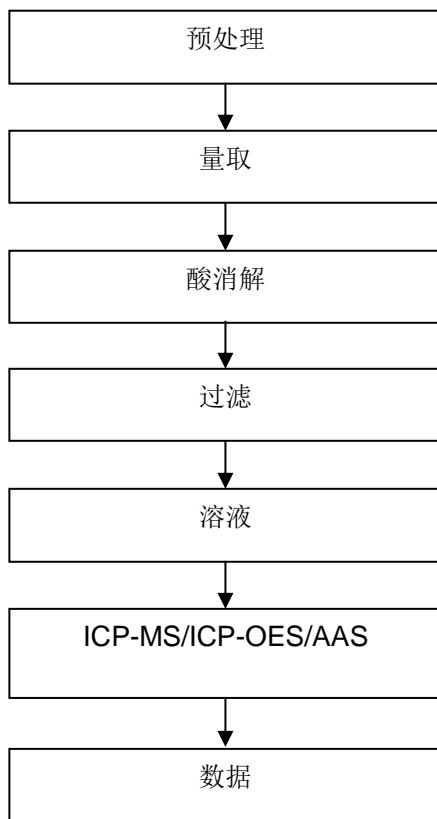
