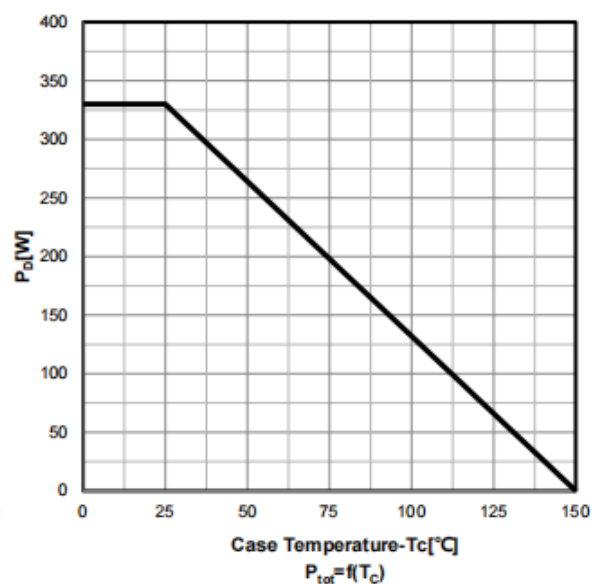

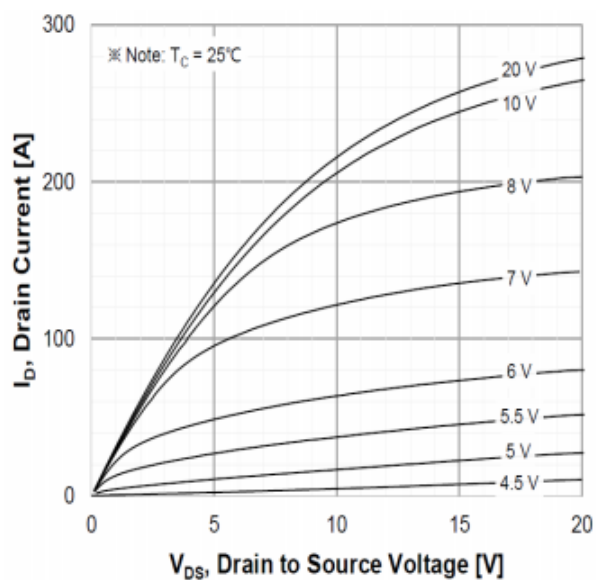

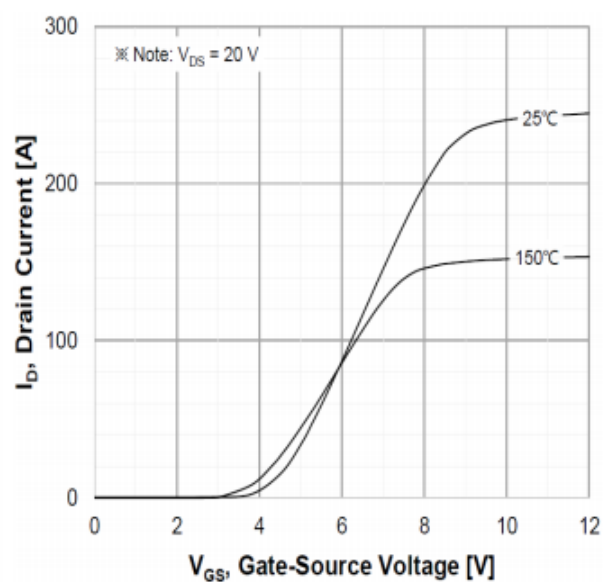
Power dissipation



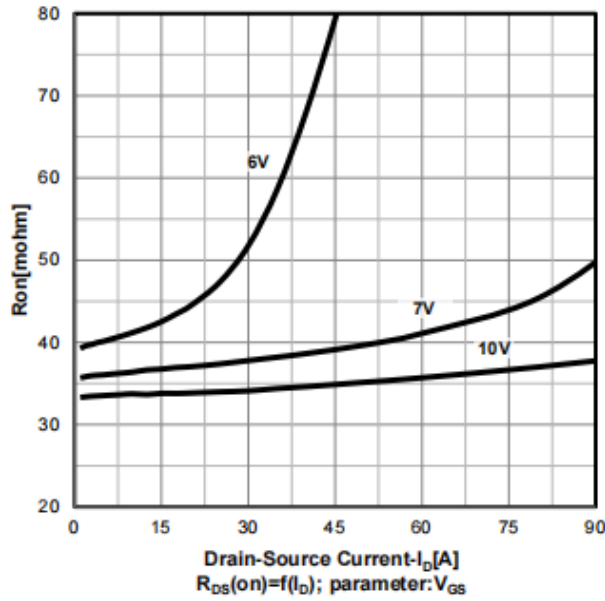
Typ. output characteristics $T_J=25\text{ }^{\circ}\text{C}$



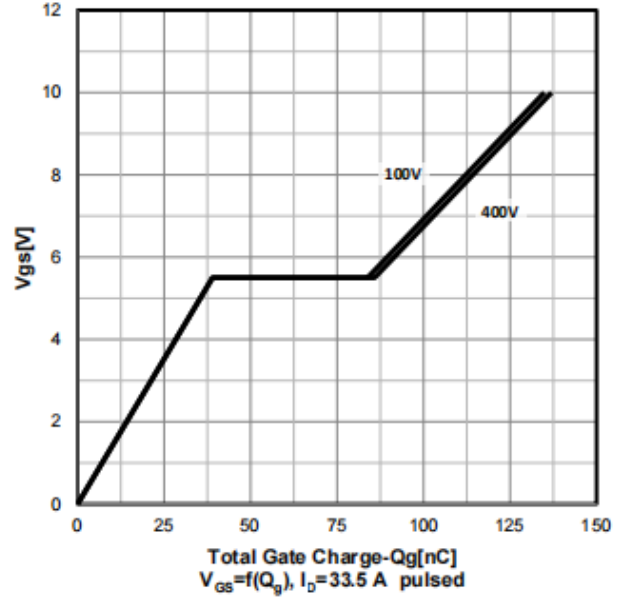
Transfer characteristics



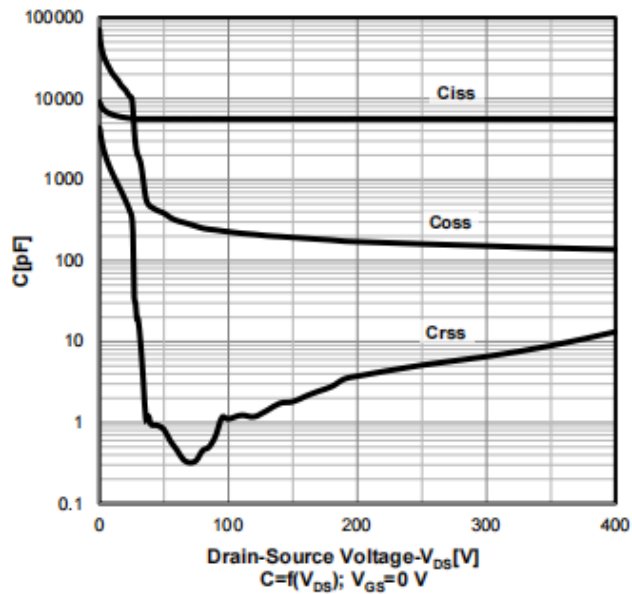
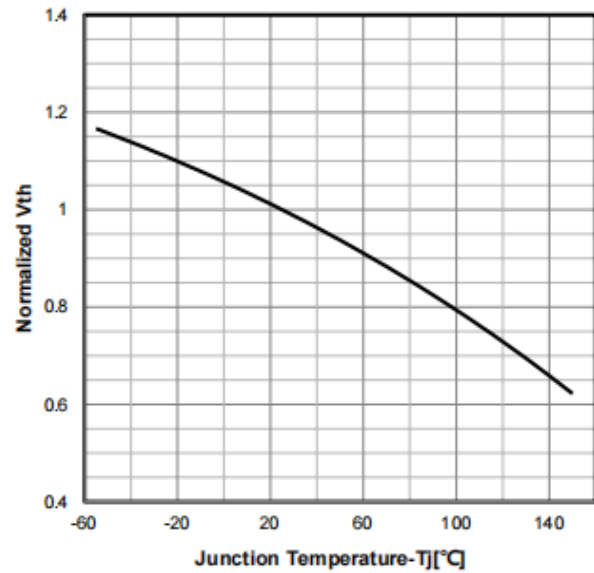
Typ. drain-source on-state resistance



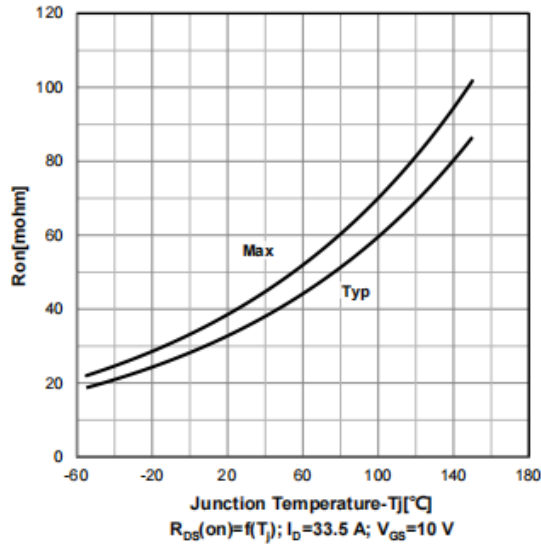
Typ. gate charge characteristics



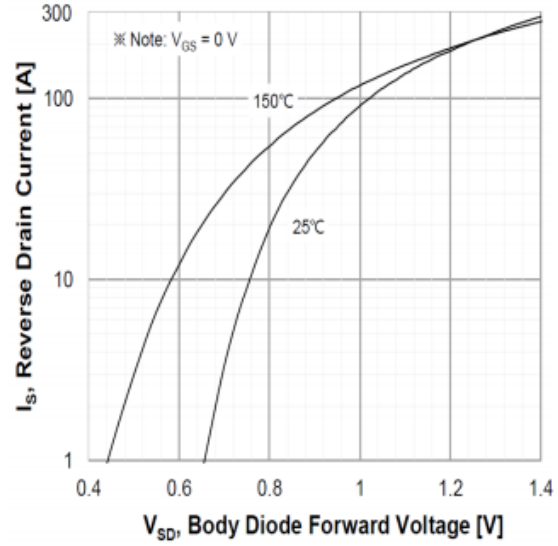

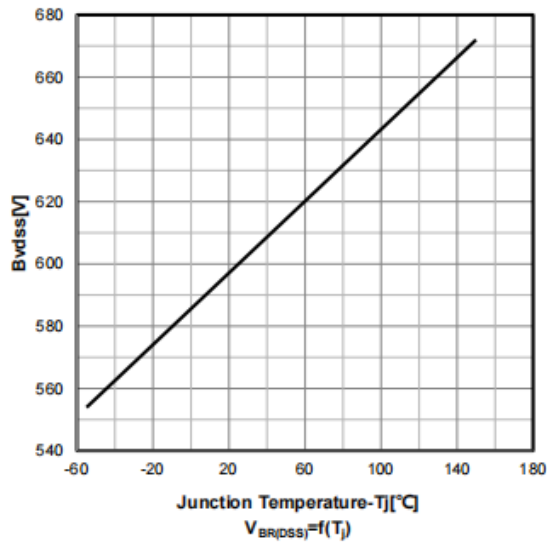
On-resistance vs temperature



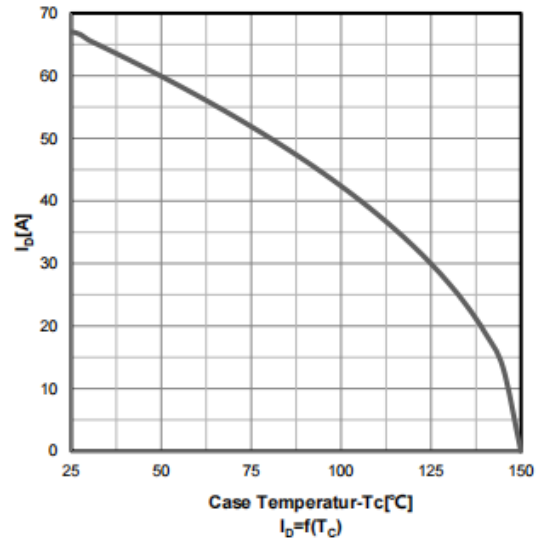
Forward characteristics of reverse diode
