Performance Curves

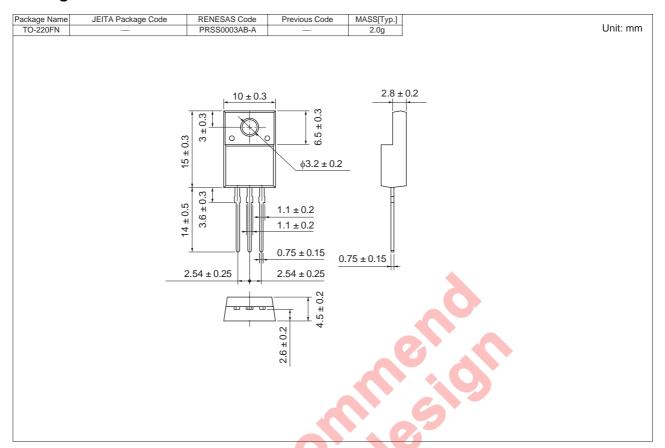
