

Fig. 1. Power derating curve










Fig. 4. DC current gain as a function of collector current; typical values

Fig. 5. Collector-emitter saturation voltage as a function of collector current; typical values











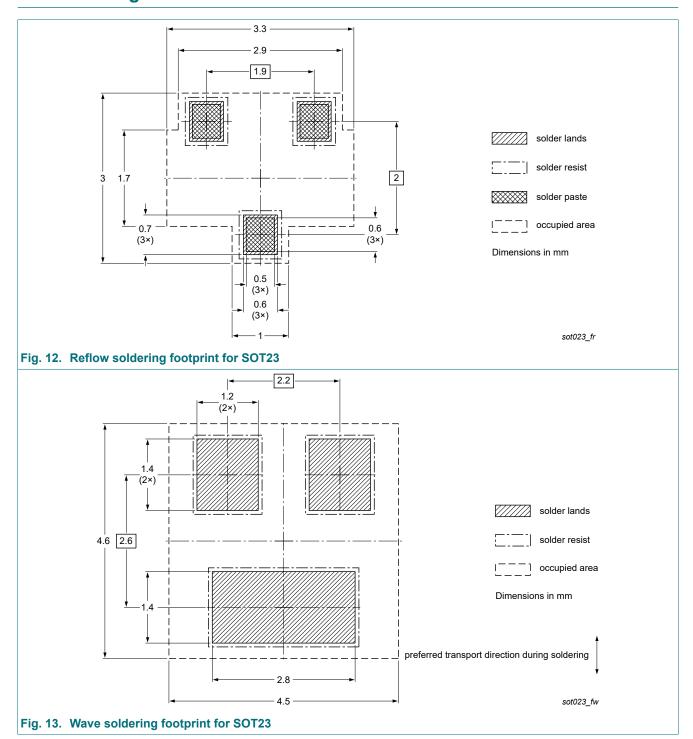
