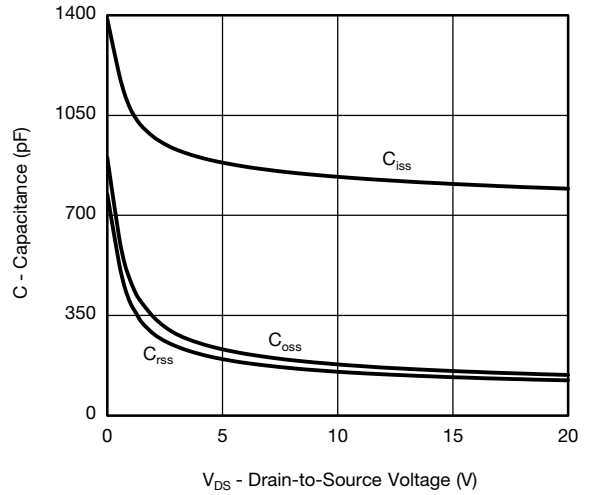

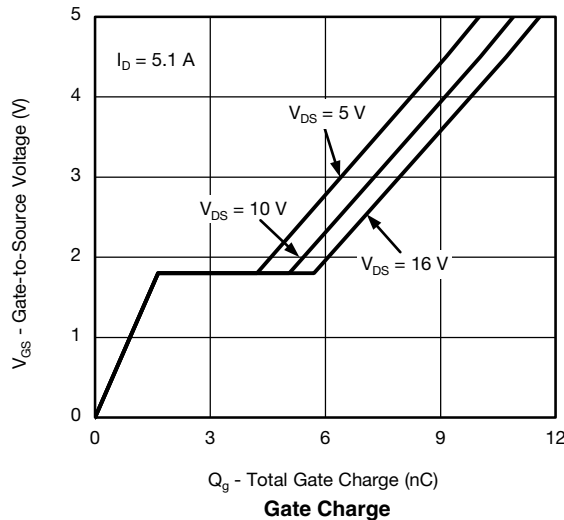

**Capacitance**

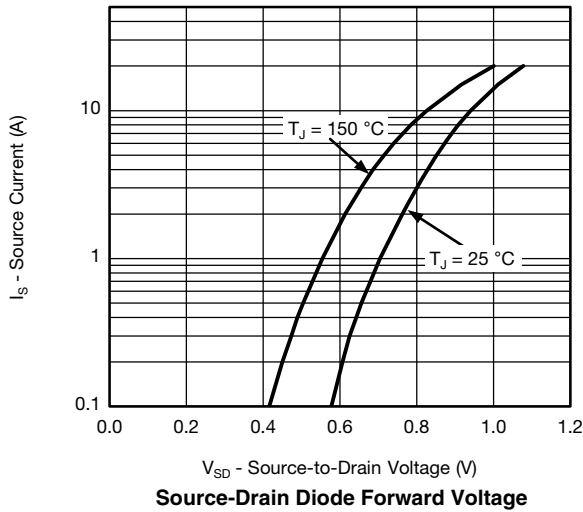


**Gate Charge**
