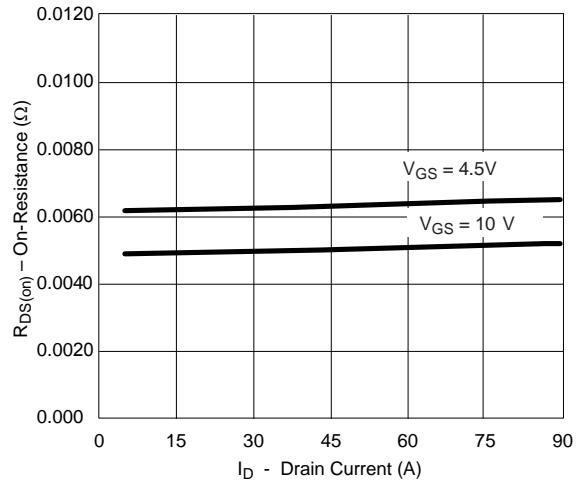

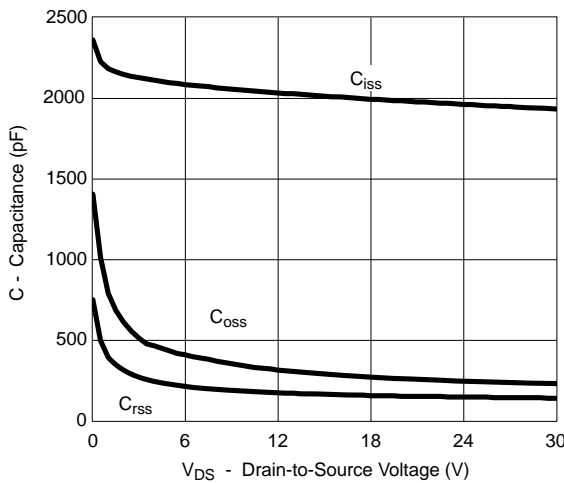

Capacitance

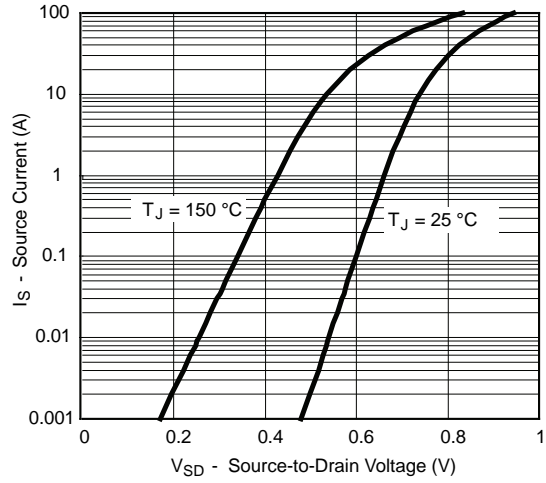

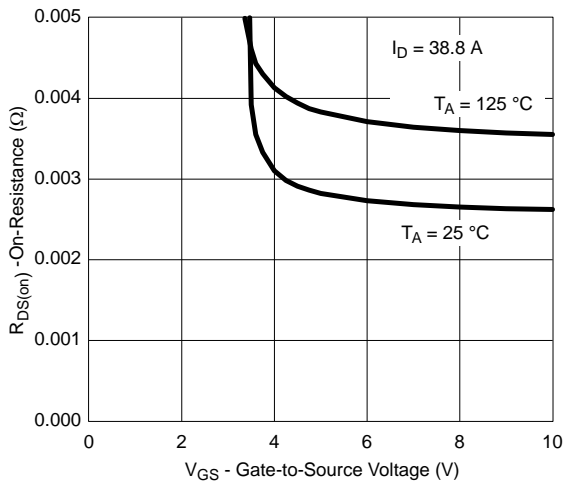

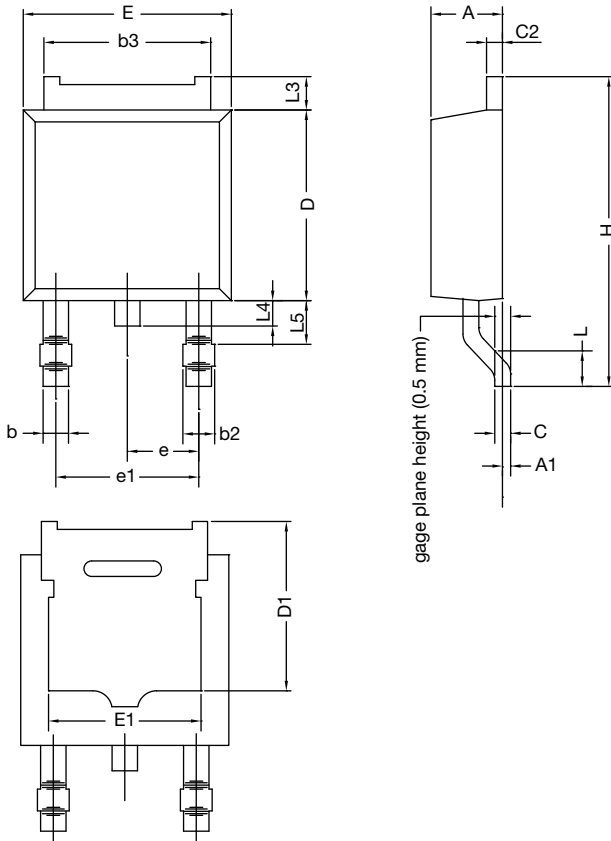
