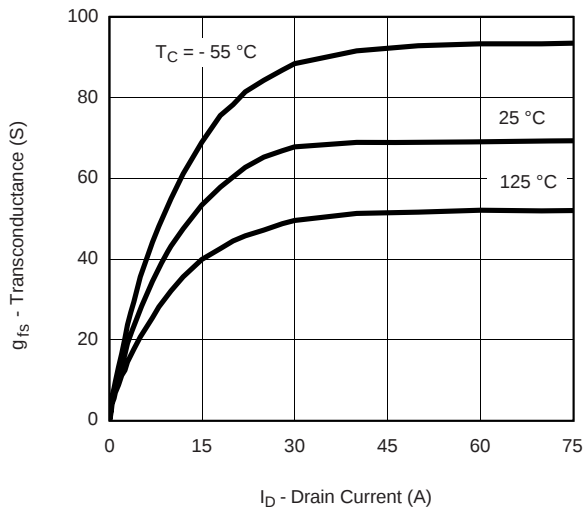

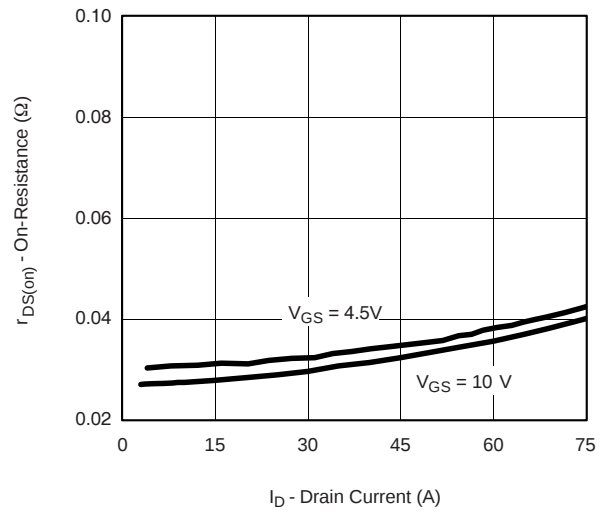

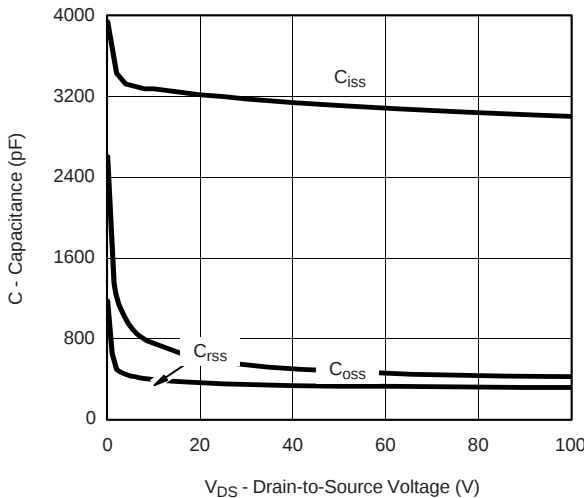

Avalanche Current vs. Time

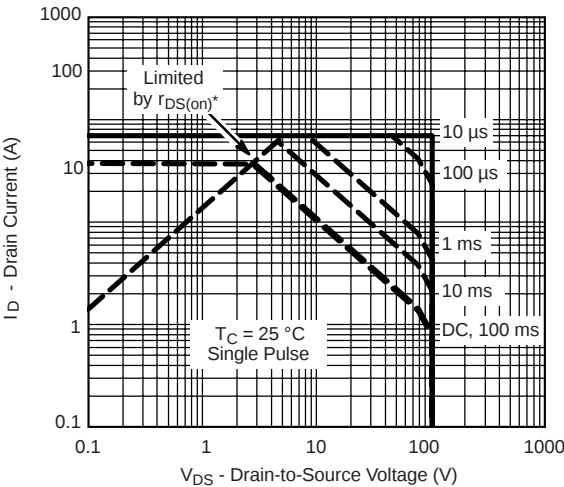


Drain-Source Breakdown Voltage vs. Junction Temperature

vs. Case Temperature

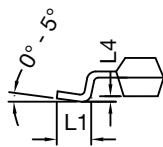
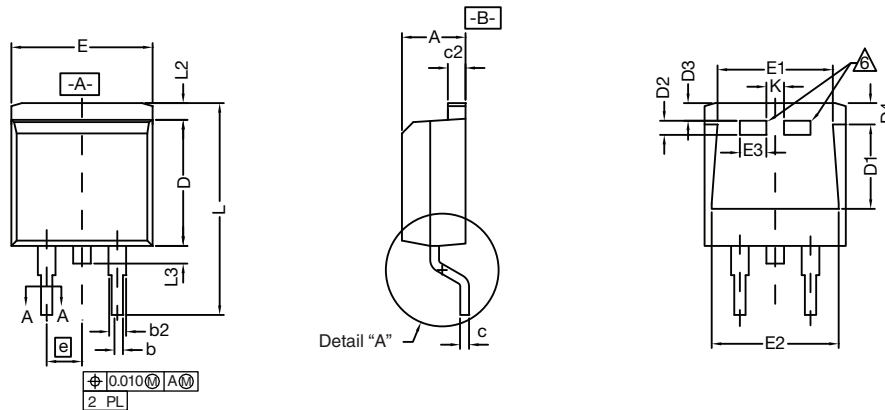

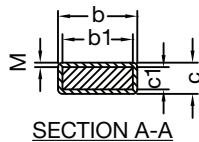


Normalized Thermal Transient Impedance, Junction-to-Case
