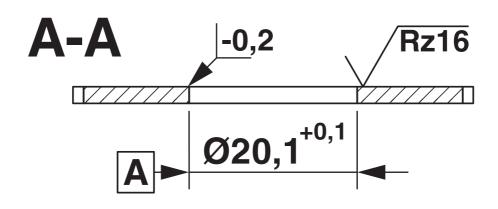





Installation dimensions




