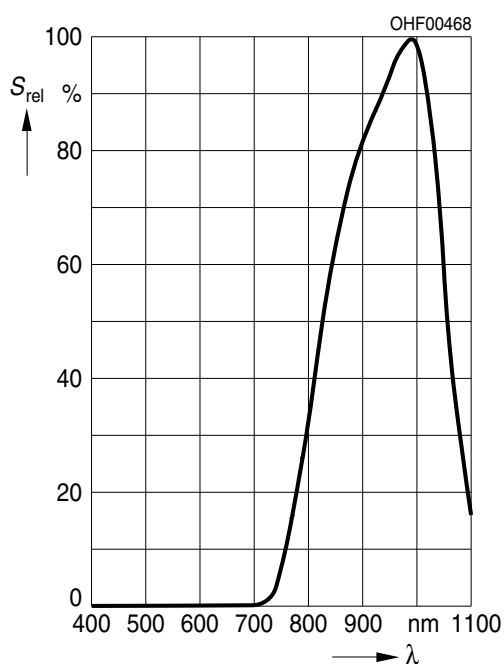

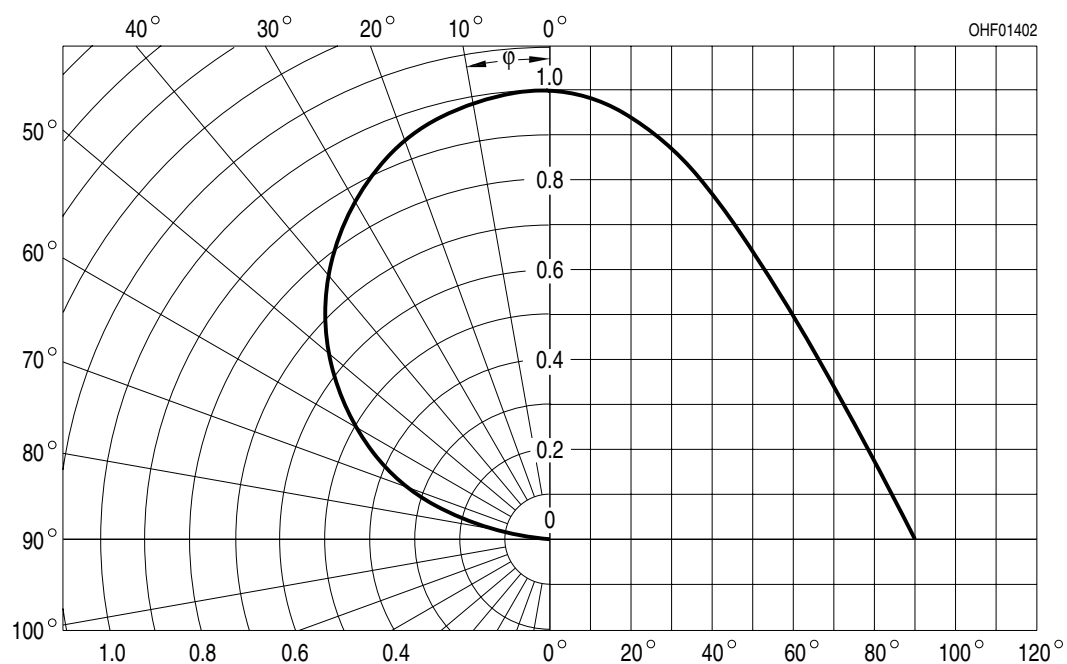

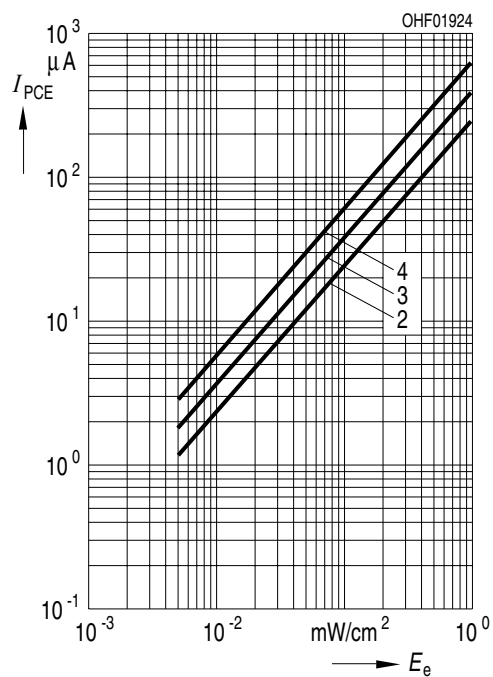

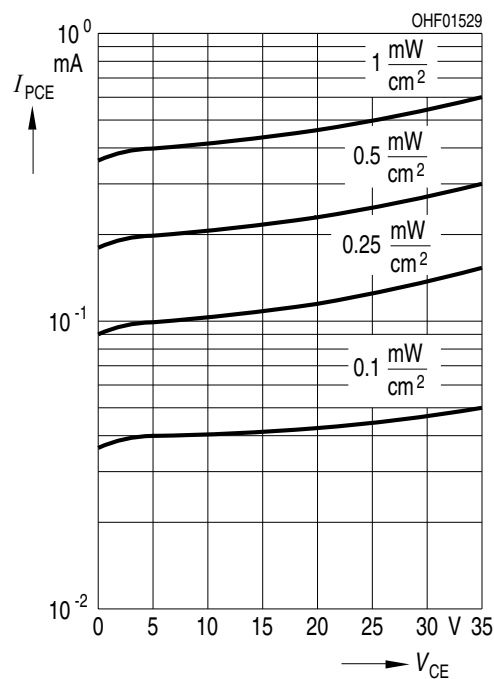

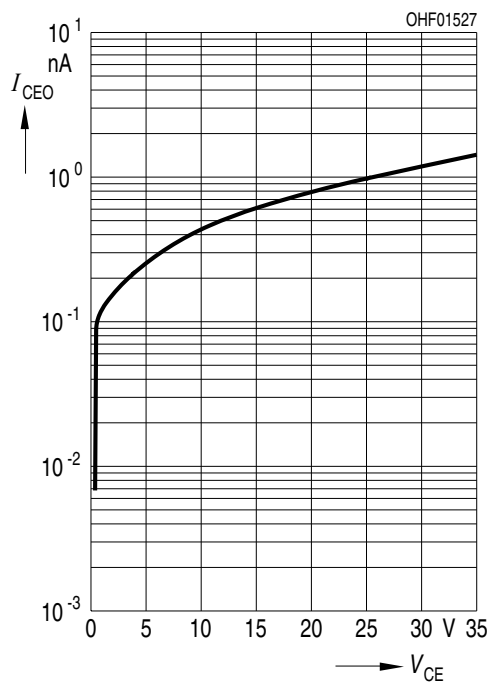

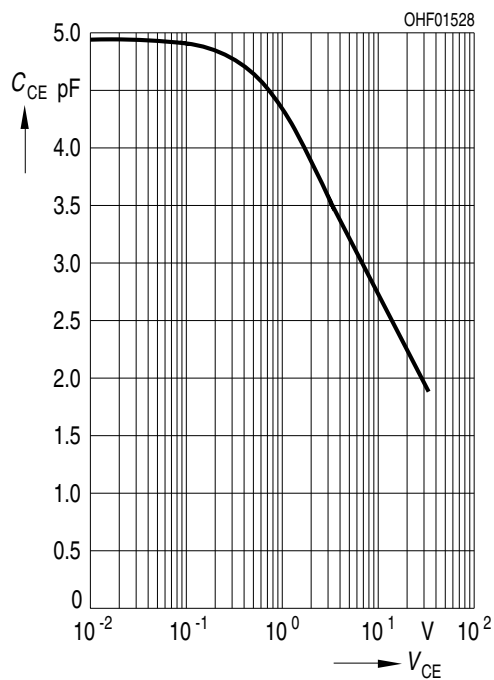


Dark Current ^{2), 3)}

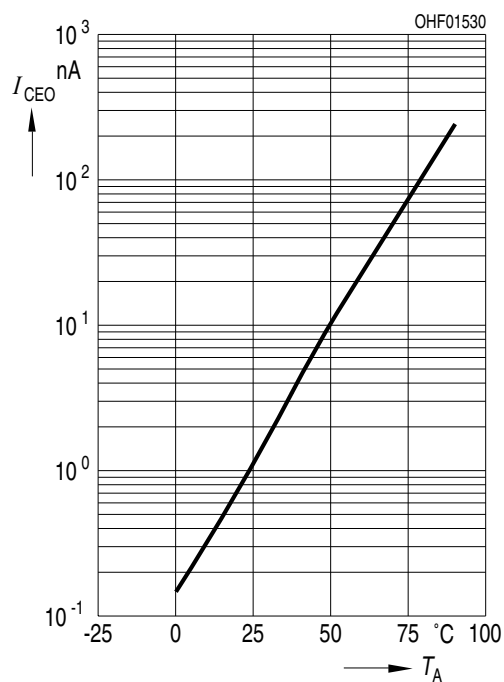
**Collector-Emitter Capacitance** ^{2), 3)}

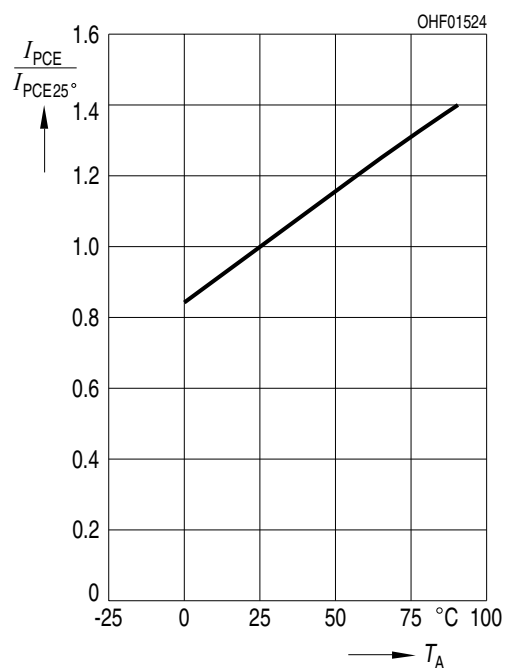

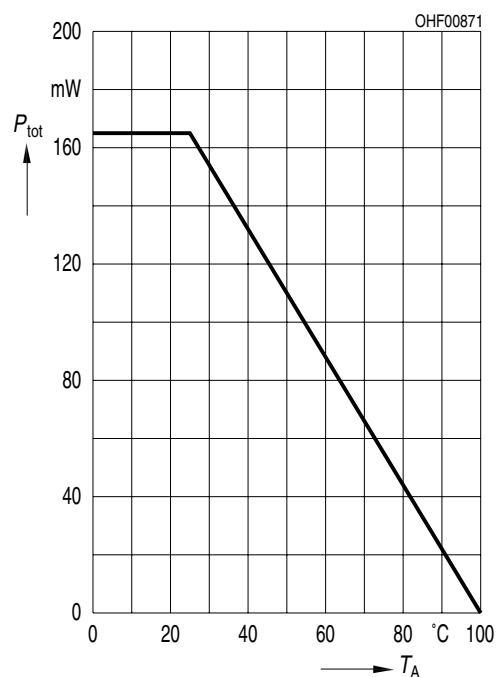

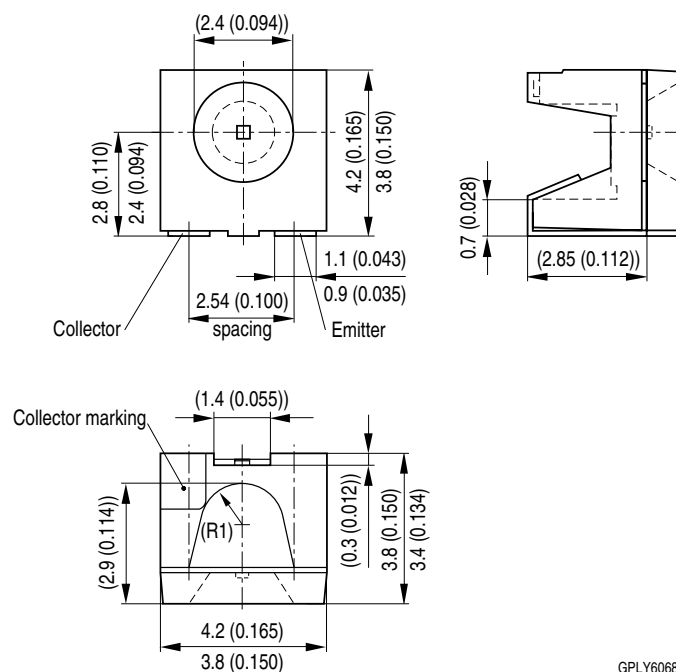


Power Consumption

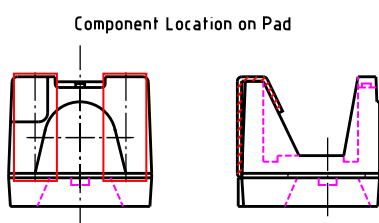
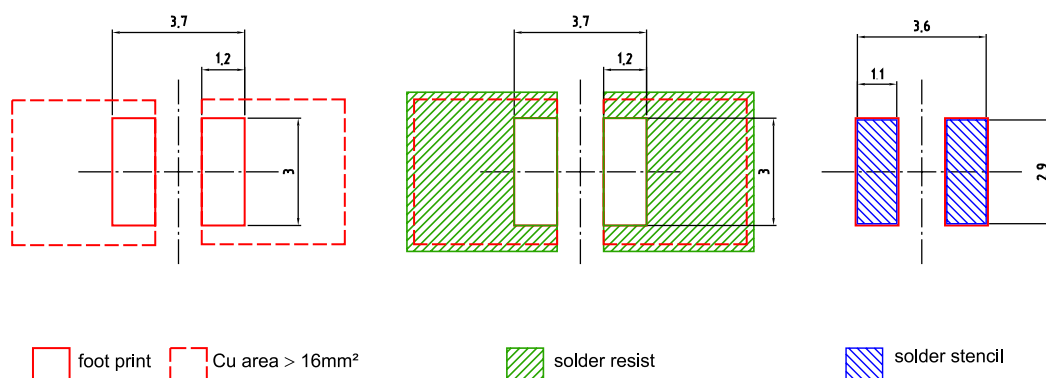
Dimensional Drawing ⁴⁾

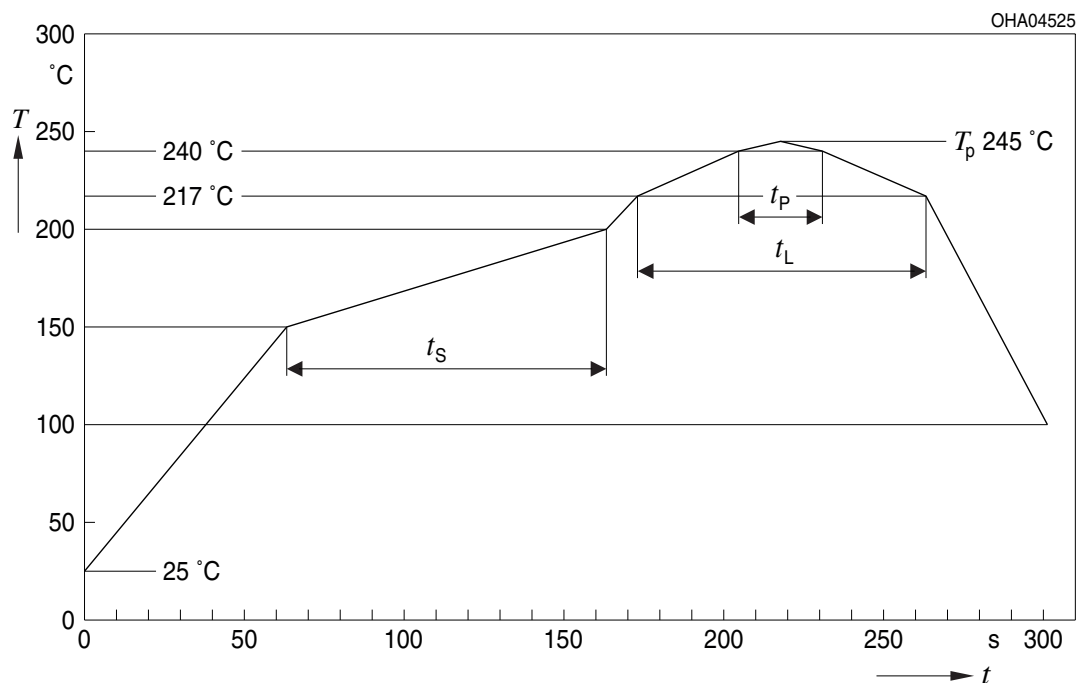
Recommended Solder Pad ⁴⁾

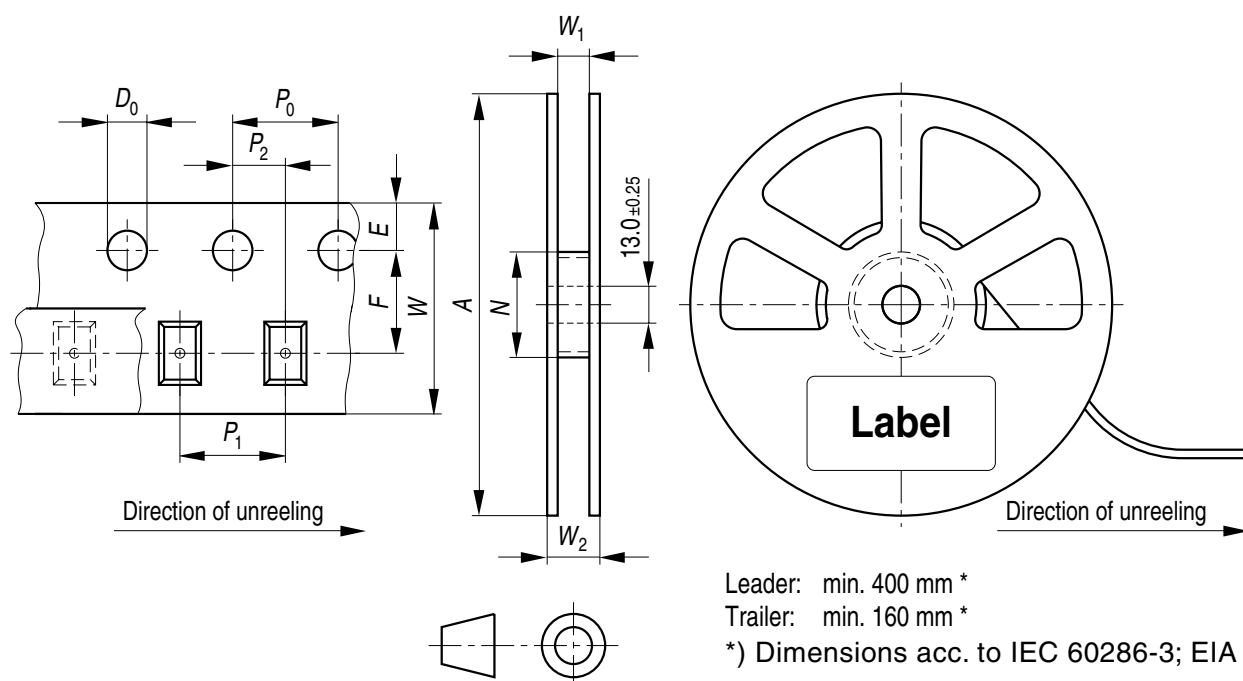

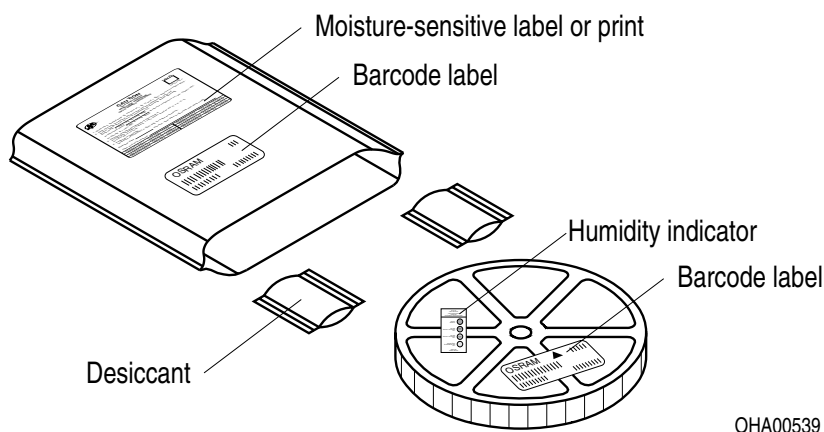

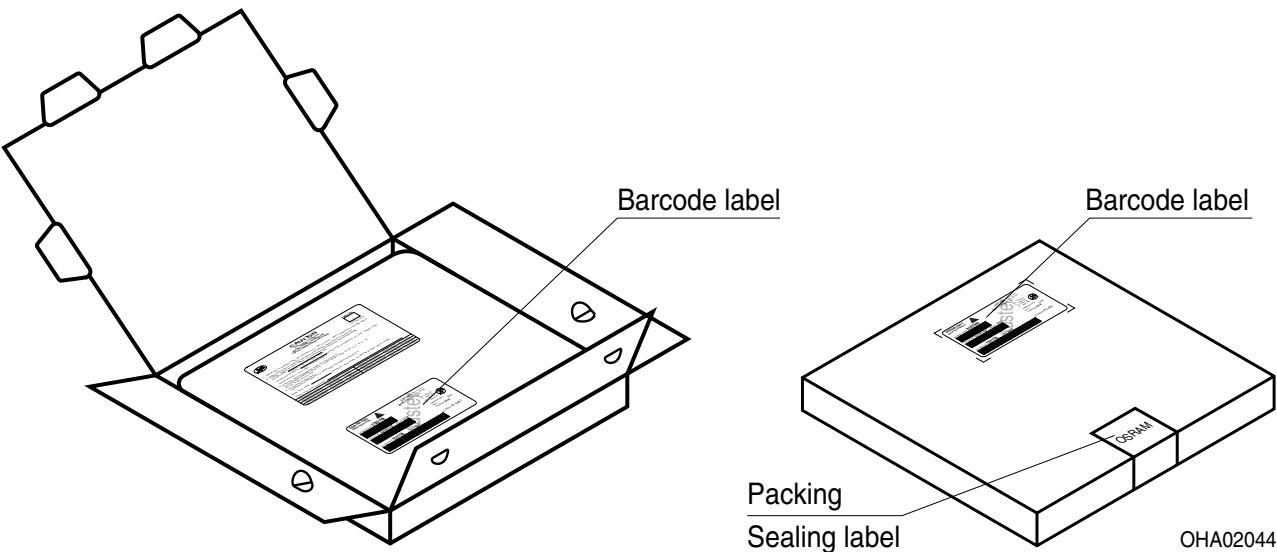


Dry Packing Process and Materials ⁴⁾

Notes
