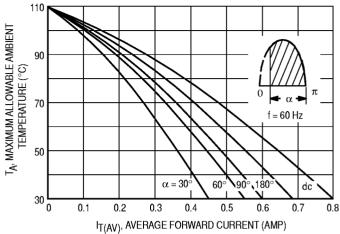

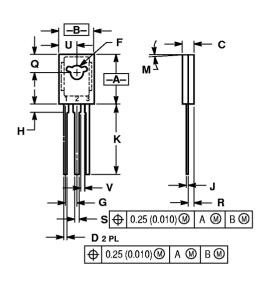


## FIGURE 2 – MAXIMUM AMBIENT TEMPERATURE
