# **POWER DISSIPATION DERATING CURVE** 40




CASE TEMPERATURE Tc (°C)




DRAIN-SOURCE VOLTAGE VDS (V)

#### **OUTPUT CHARACTERISTICS** (TYPICAL)










DRAIN-SOURCE VOLTAGE VDs (V)




