

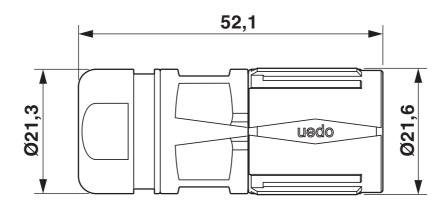

Dimensional drawing




