


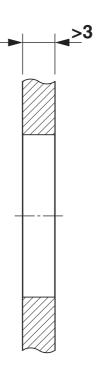


Installation dimensions
