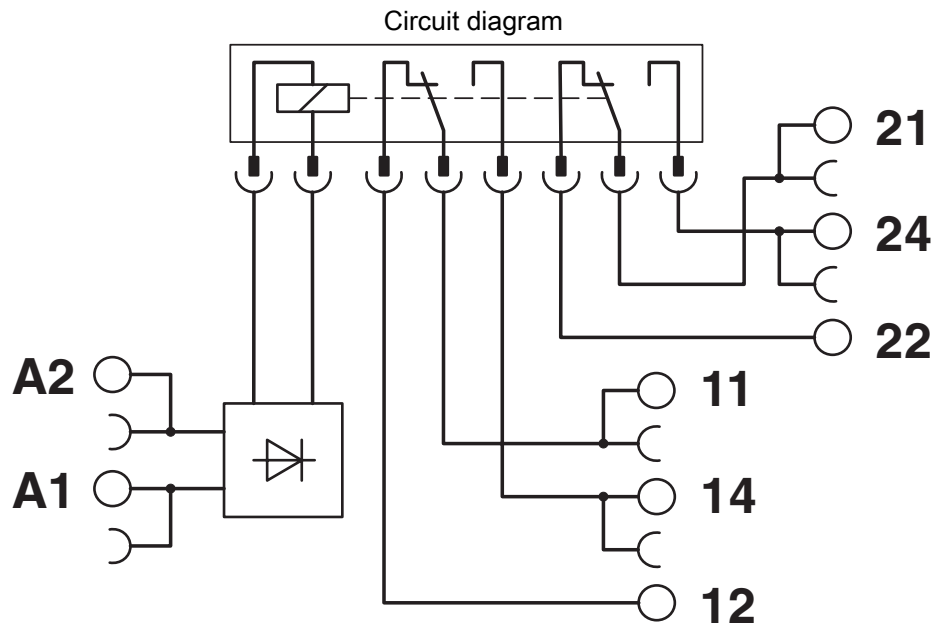

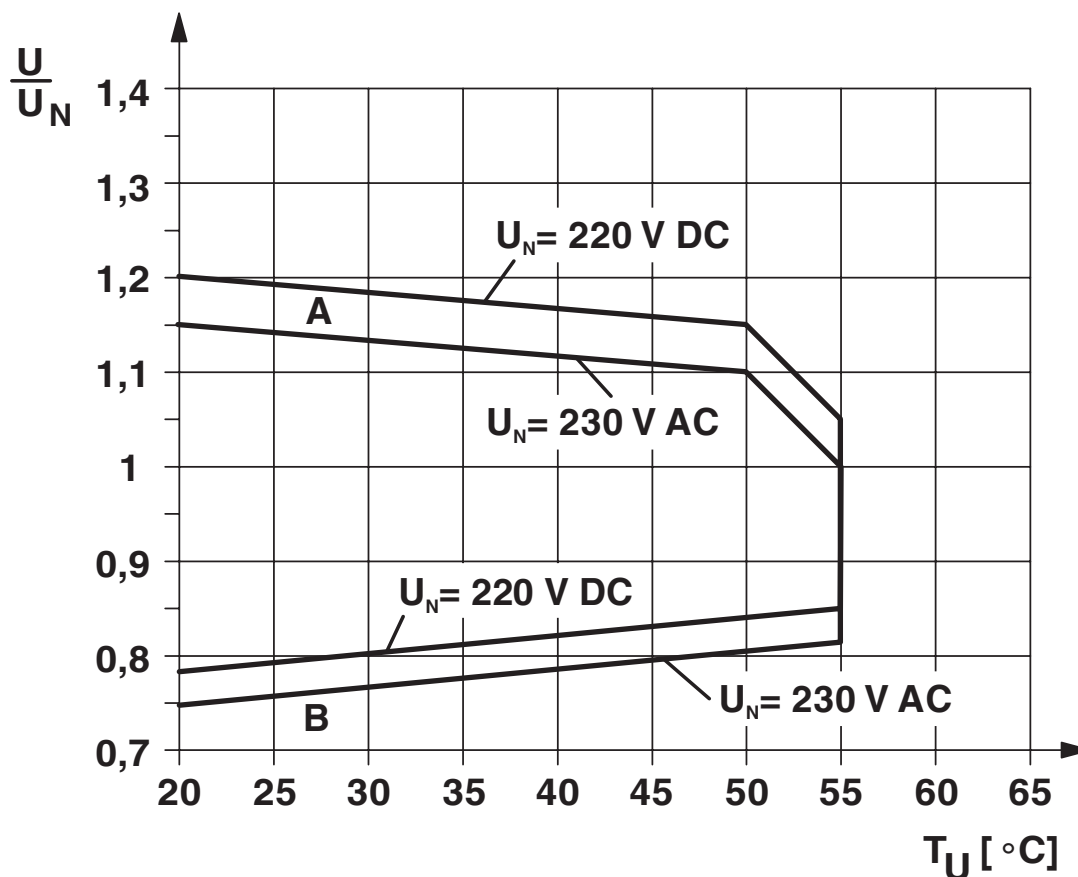

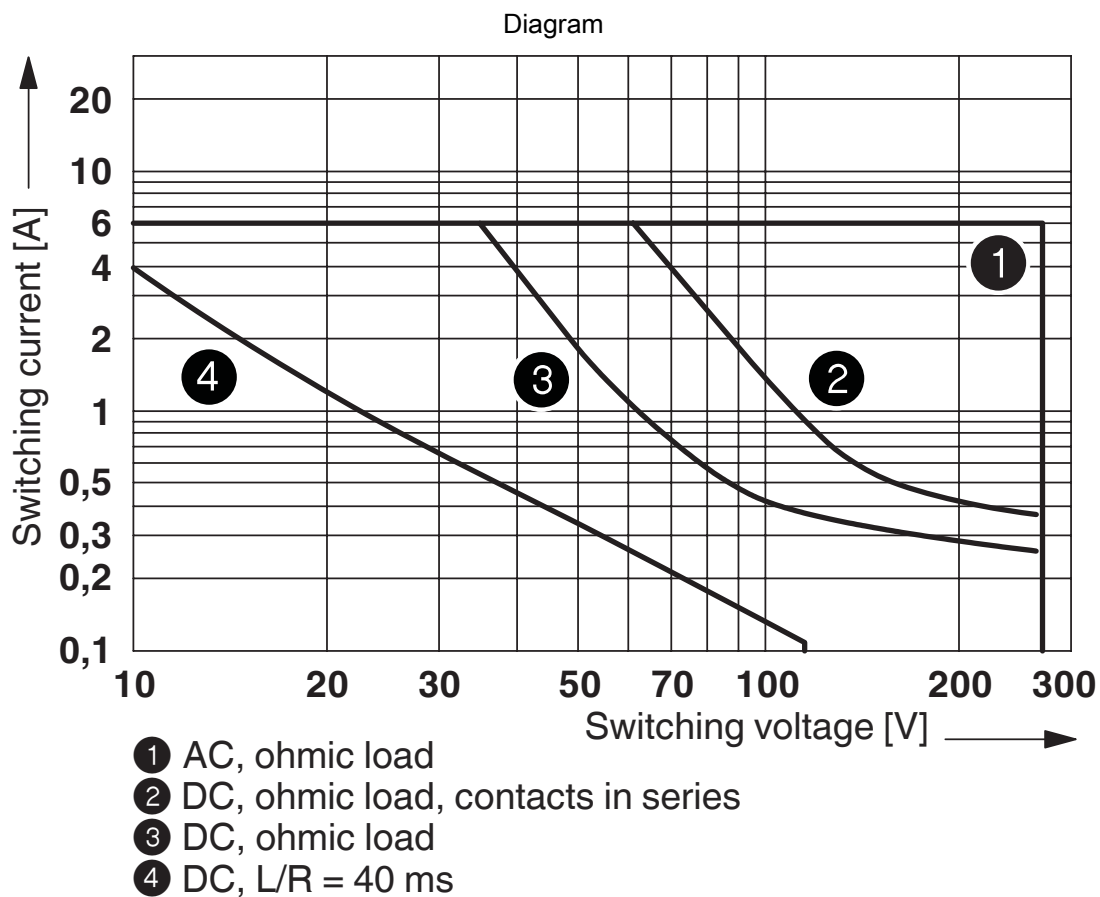


Curve A

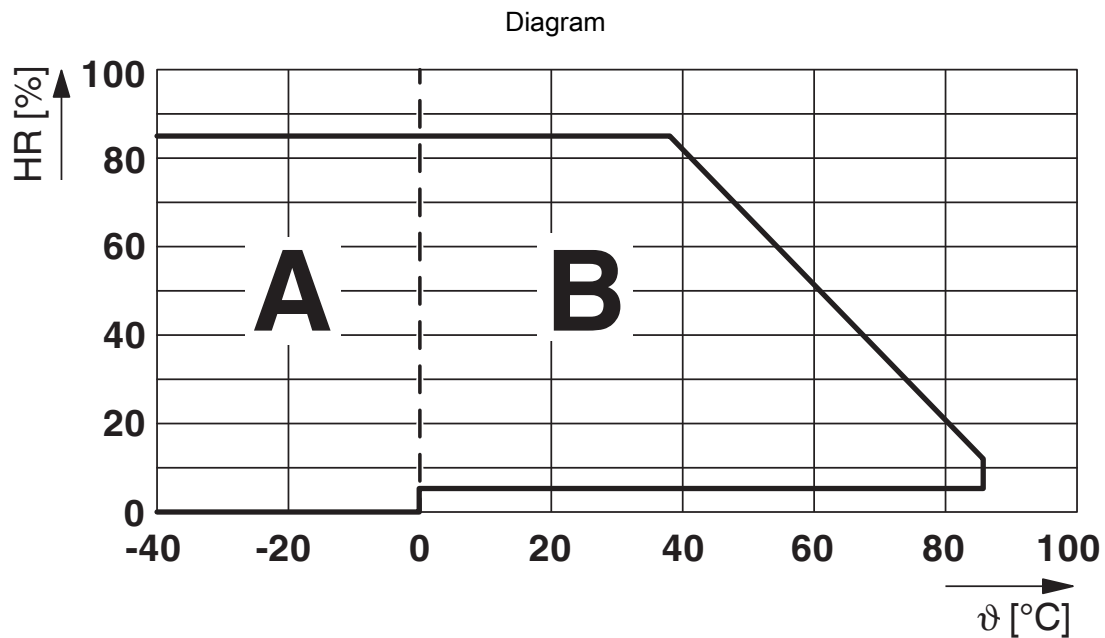
Maximum permissible continuous voltage $U_{\max}$ with limiting continuous current on the contact side (see relevant technical data)
