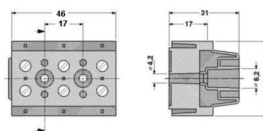

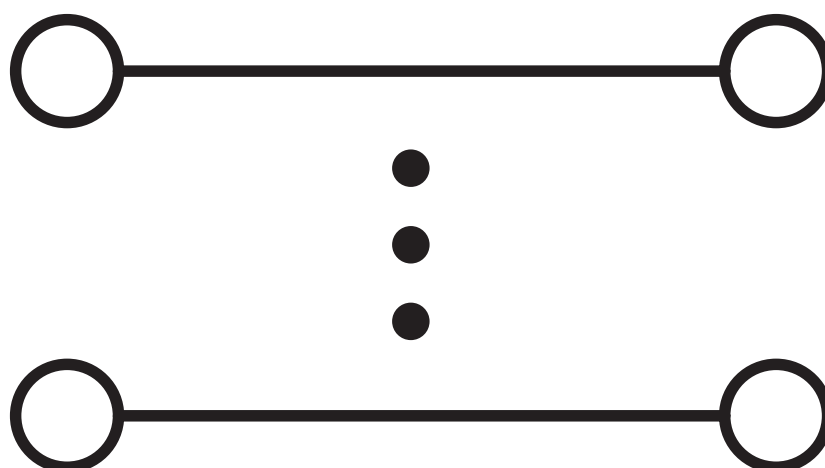

Circuit diagram



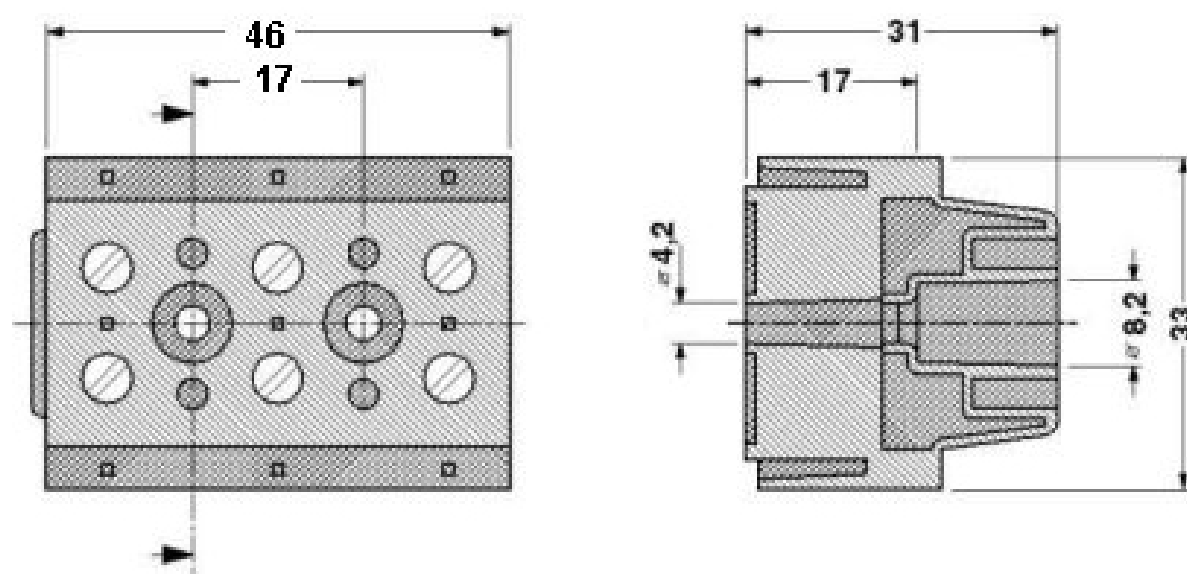
