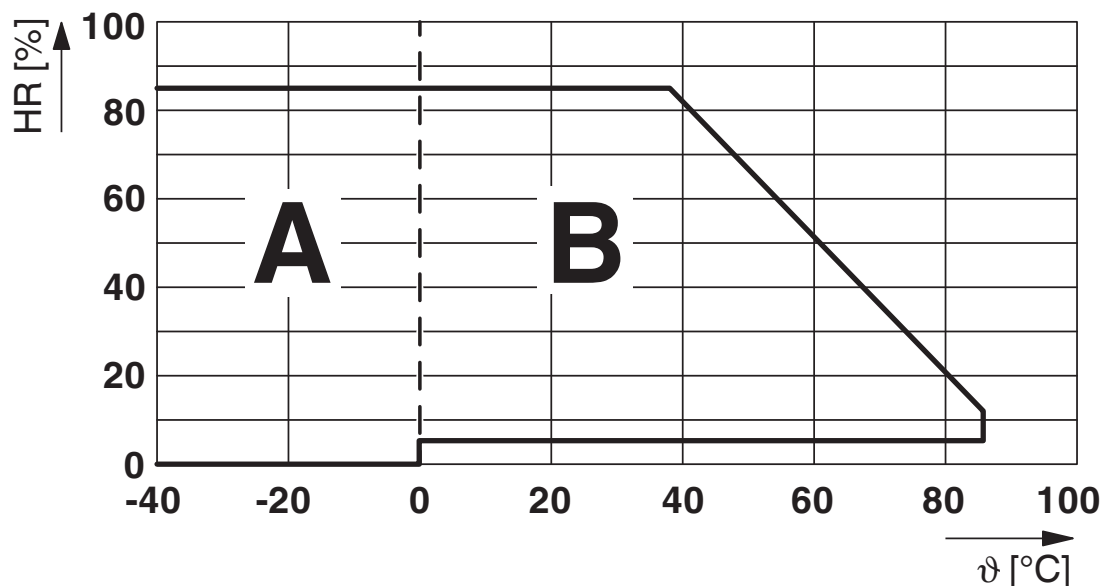

Permissible humidity for operation and storage.

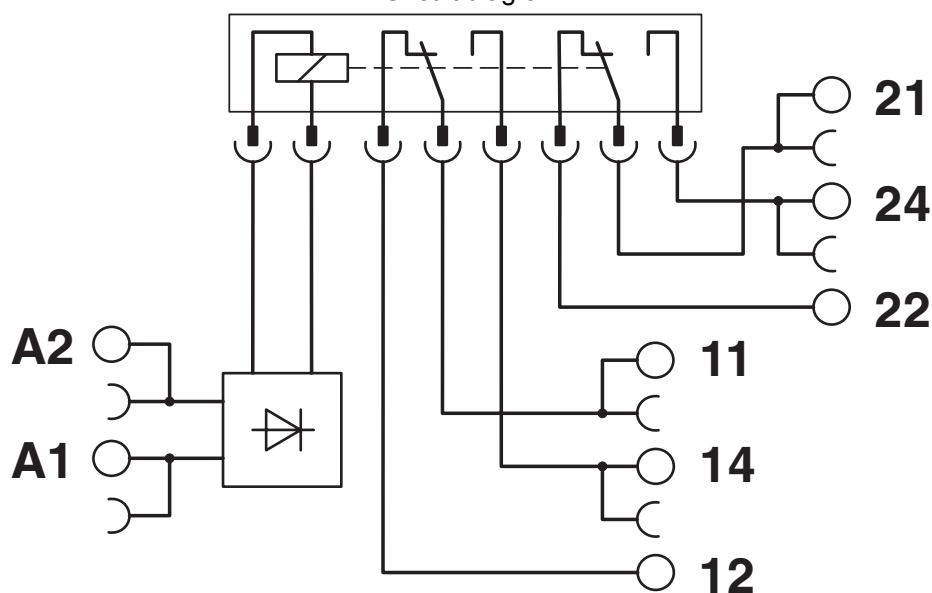

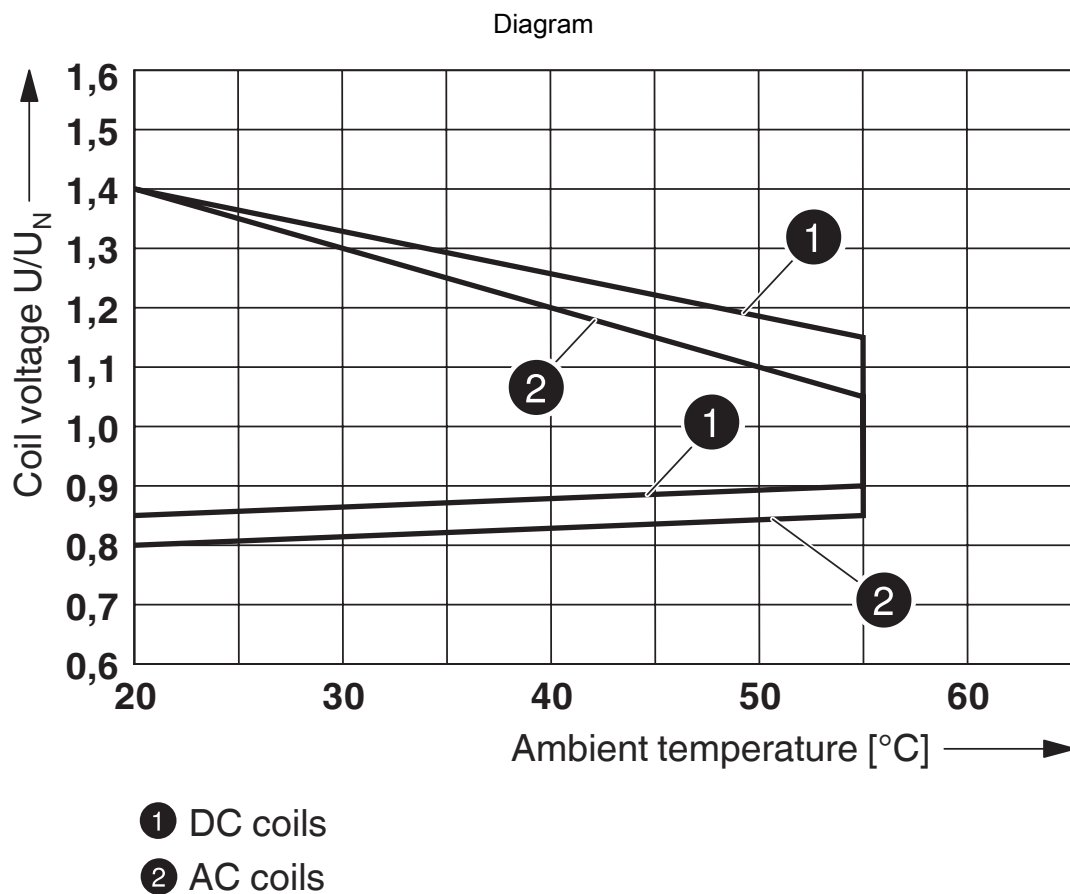

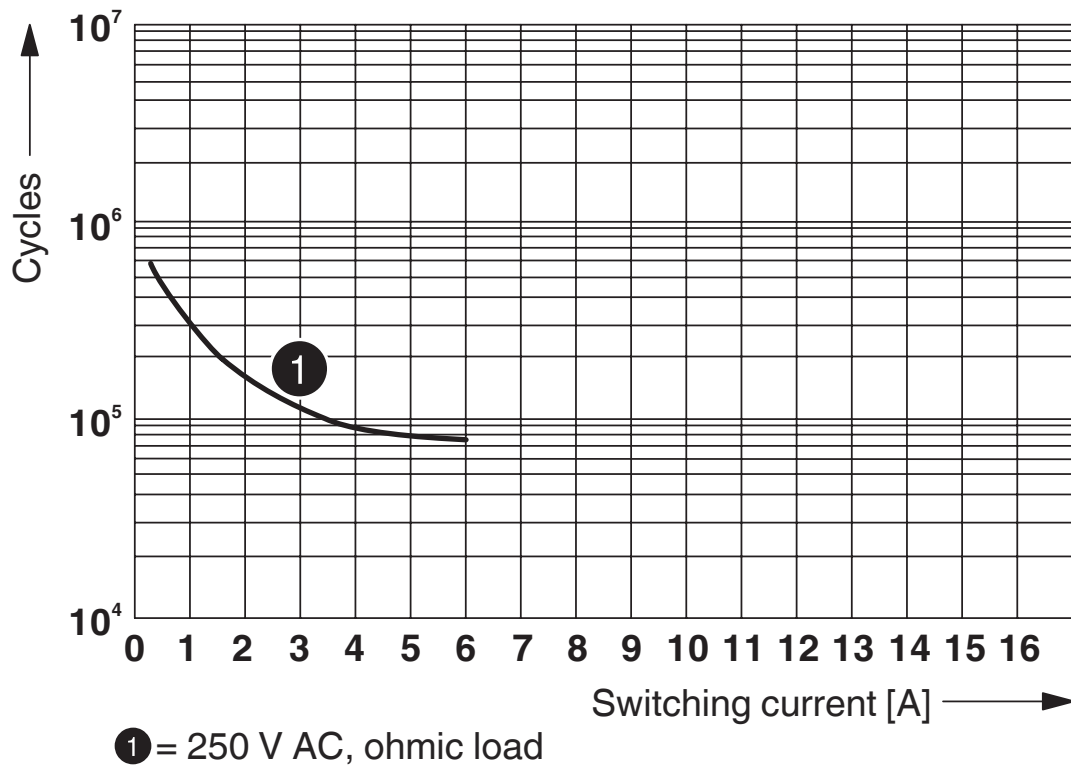
Circuit diagram

Diagram

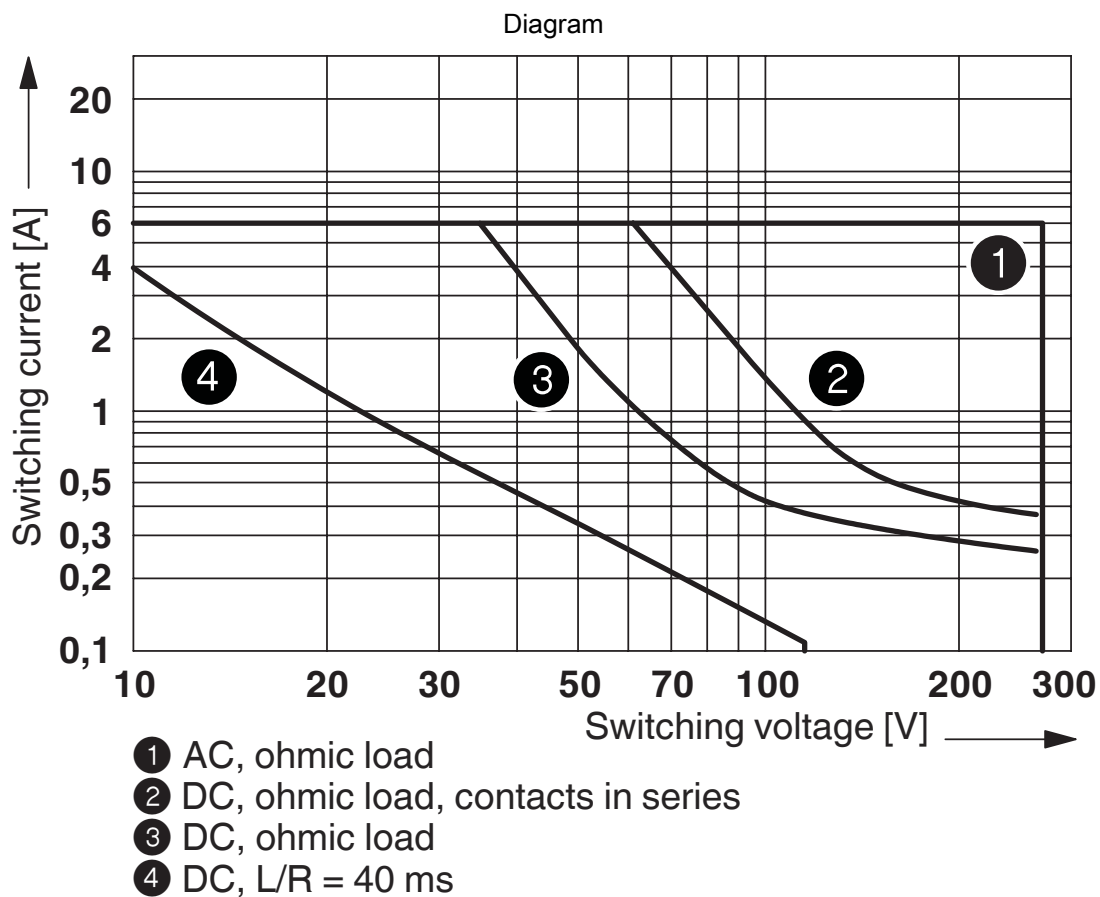


Electrical service life
