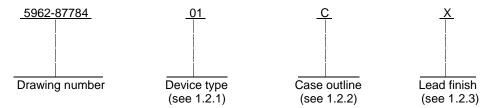

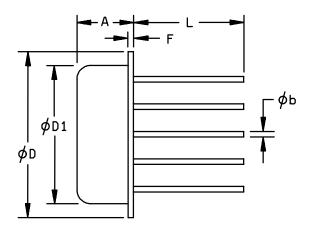

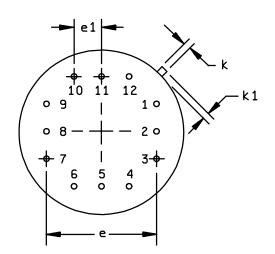

4. QUALITY ASSURANCE PROVISIONS
