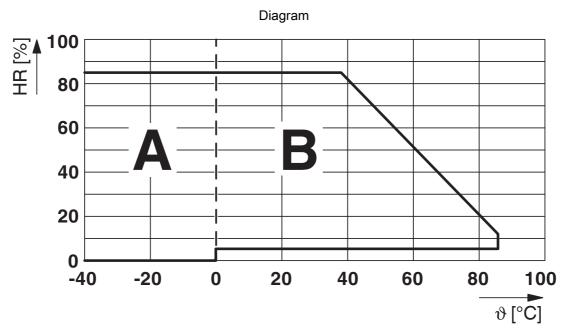



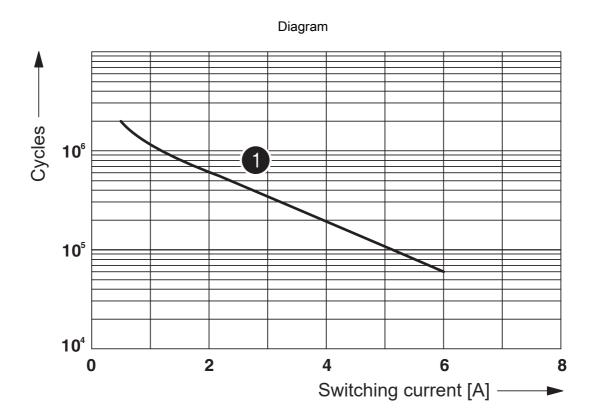
Circuit diagram
