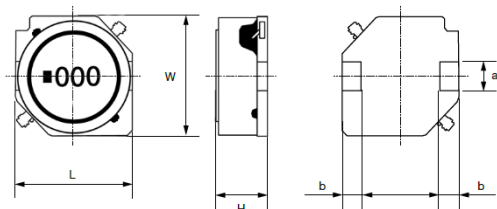

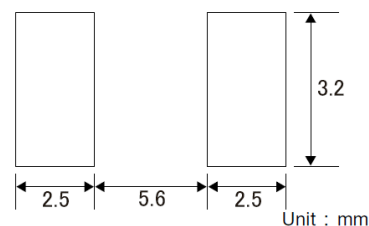

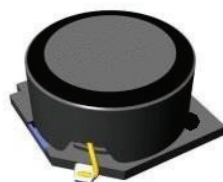

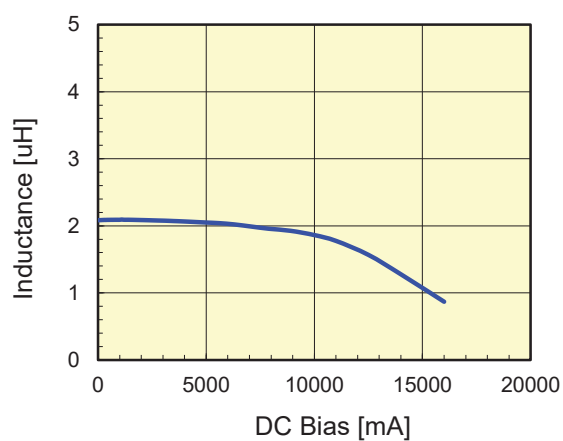

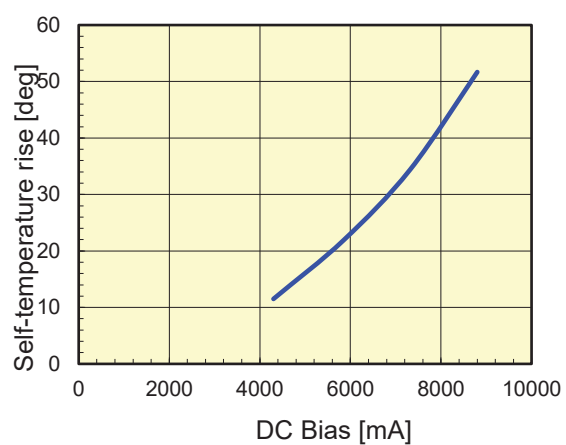

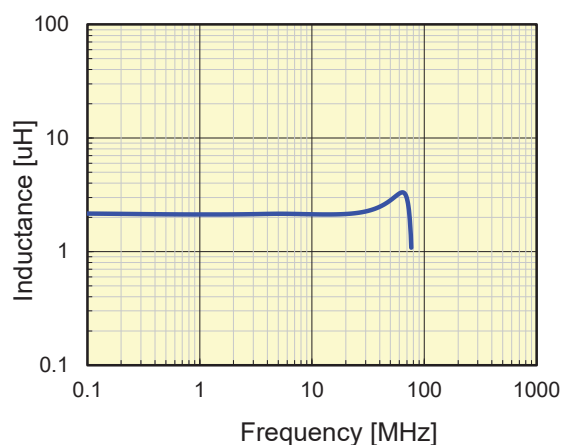
DC Bias vs Inductance
