





Dimensional drawing





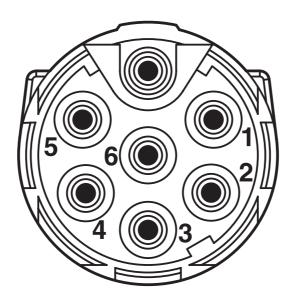
Installation dimensions
