

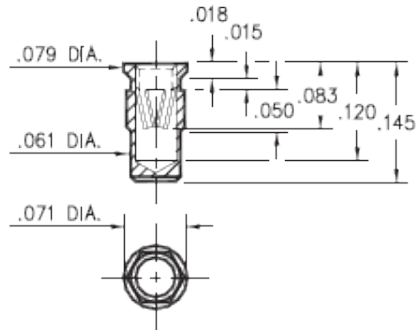

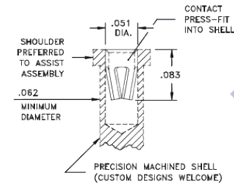

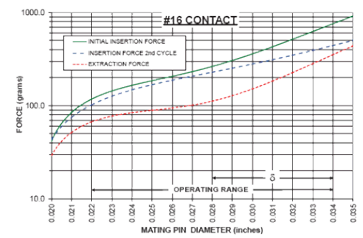

BRASS ALLOY (UNS C36000) per ASTM B 16

Properties of BRASS ALLOY:
