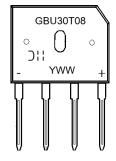

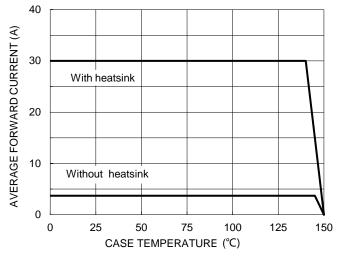


Figure 1. Forward Current Dearting Curve

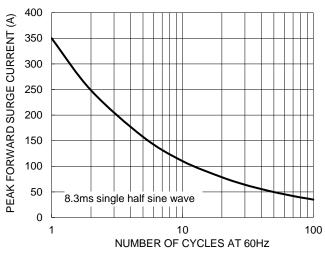


Figure 2. Maximum Non-Repetitive Surge Current

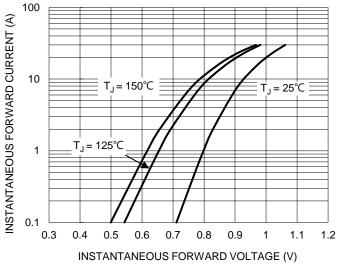


Figure 3. Typical Forward Characteristics

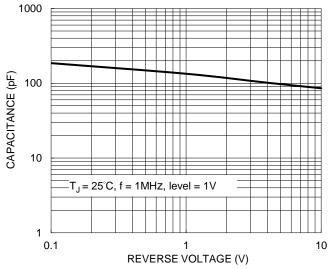


Figure 4. Typical Junction Capactiance

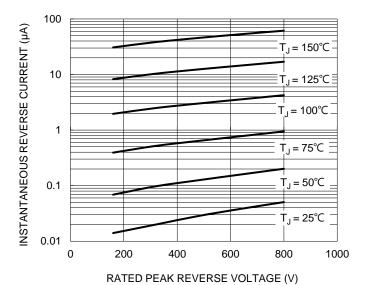


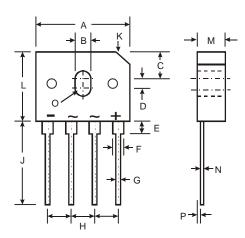
Figure 5. Typical Reverse Characteristics
