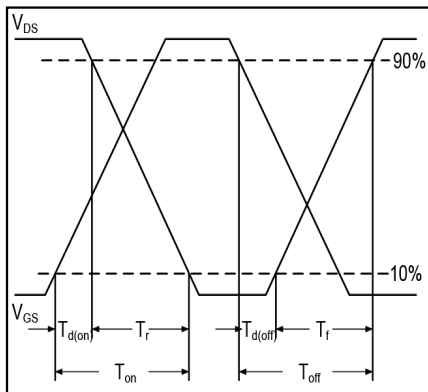


FIG.7-Switching Time Waveform

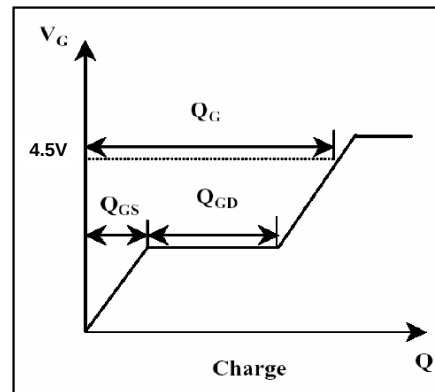


FIG.8-Gate Charge Waveform

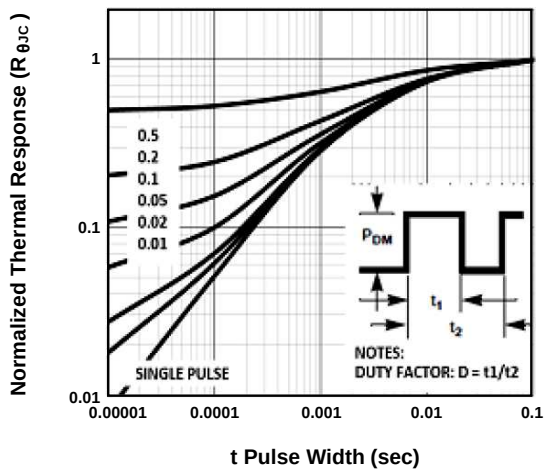


FIG.9-Transient Thermal Impedance
