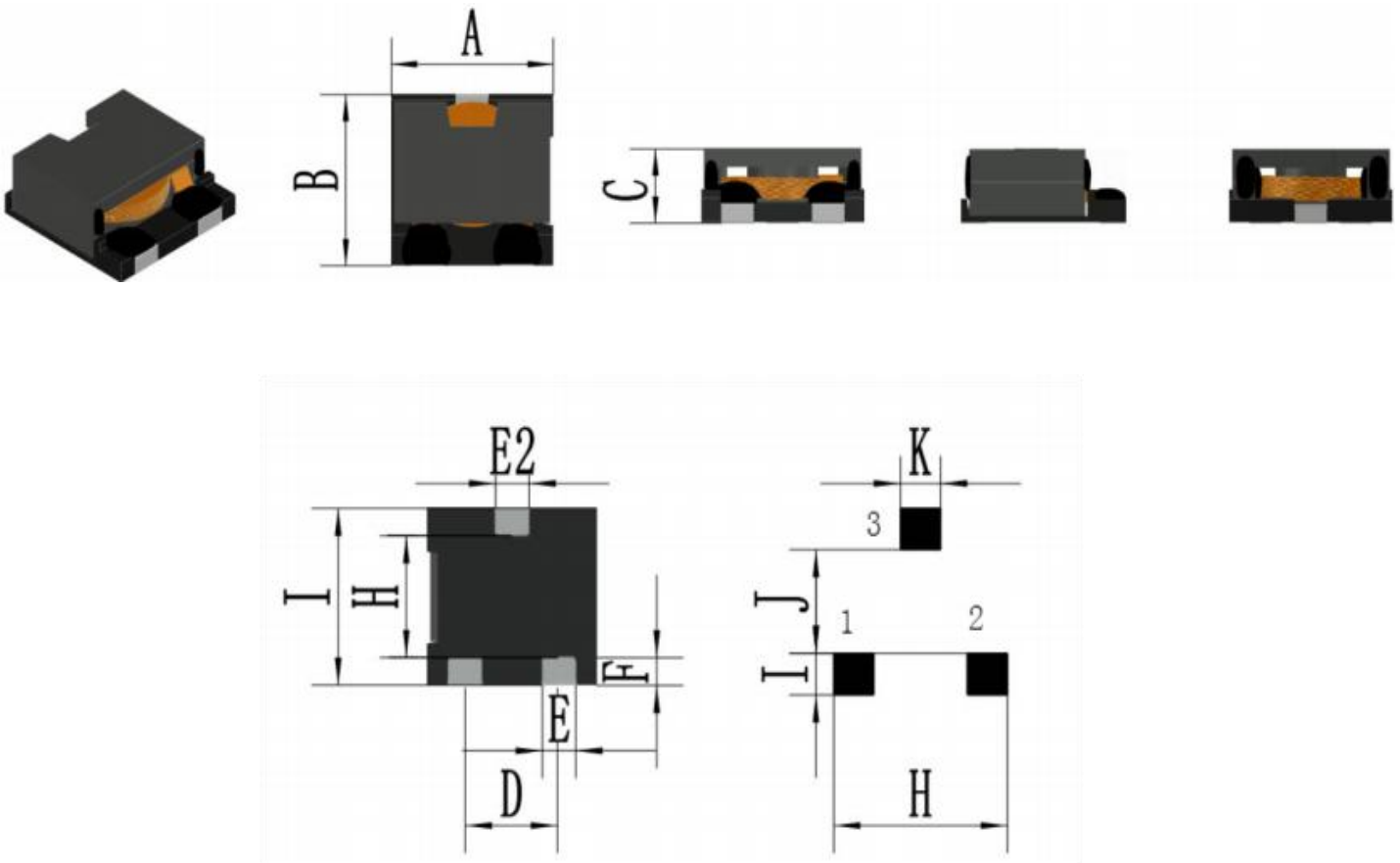

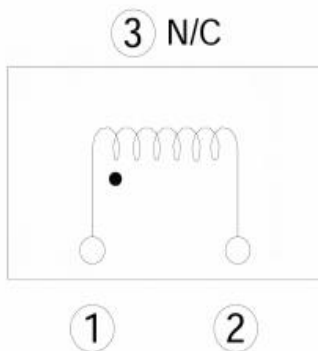

存储条件 Storage conditions

- (1) 存放货物的库房应满足以下条件：温度：-10 ~ +40℃, 相对湿度：30 ~ 70%。The warehouse for storing goods shall meet the following conditions: temperature:-10 ~+40℃ and relative humidity: 30 ~ 70%.
- (2) 禁止将产品保管在腐蚀性物质中，否则将引起端头氧化，导致降低焊接性。It is forbidden to store the product in corrosive substances, otherwise it will cause oxidation of the end and reduce the weldability.
- (3) 为了避免受潮气、灰尘等物质的影响，产品应保管于货架上。In order to avoid the influence of moisture, dust and other substances, the product should be kept on the shelf.
- (4) 产品保管在库房中，应避免热冲击、振动以及直接光照等等。When the products are stored in the warehouse, thermal shock, vibration and direct light should be avoided.
- (5) 产品应密封包装。Products should be sealed and packaged.

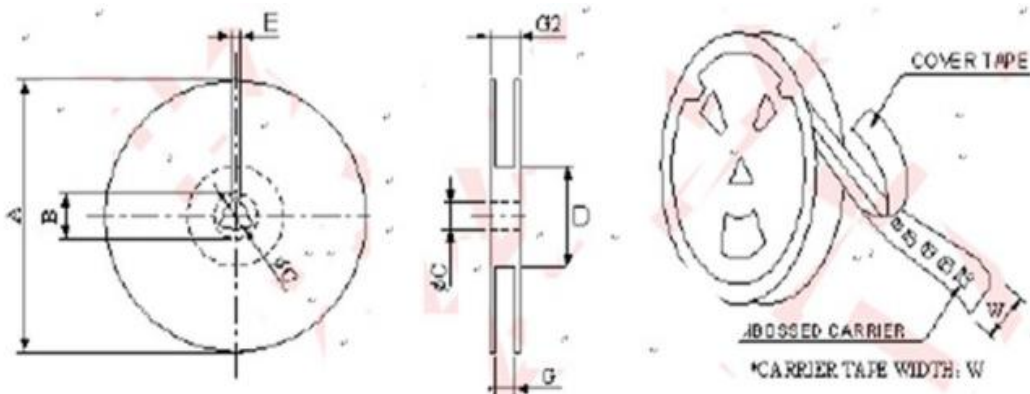

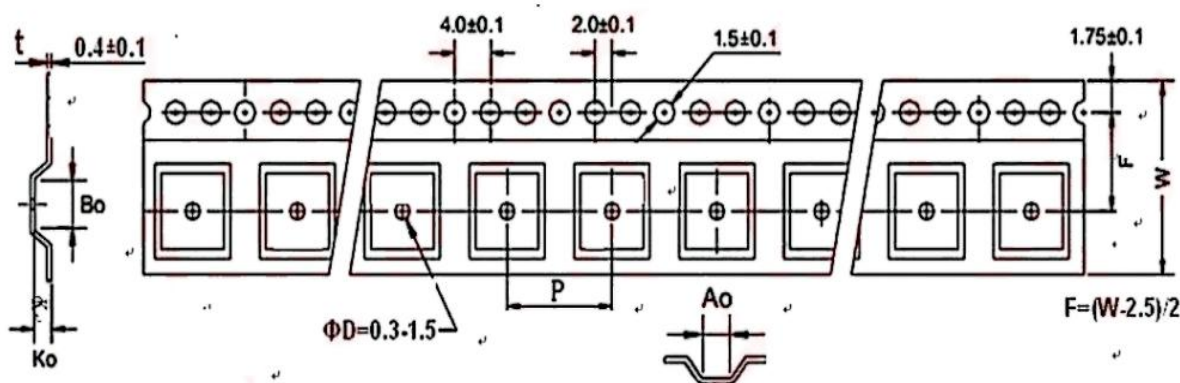
