




Fig. 1. Forward current as a function of forward voltage; typical values




Fig. 2. Reverse current as a function of reverse voltage; typical values




Fig. 3. Differential forward resistance as a function of forward current; typical values




Fig. 4. Diode capacitance as a function of reverse voltage; typical values




Fig. 5. Package outline TSSOP6 (SOT363)




Fig. 6. Reflow soldering footprint for TSSOP6 (SOT363)




Fig. 7. Wave soldering footprint for TSSOP6 (SOT363)
