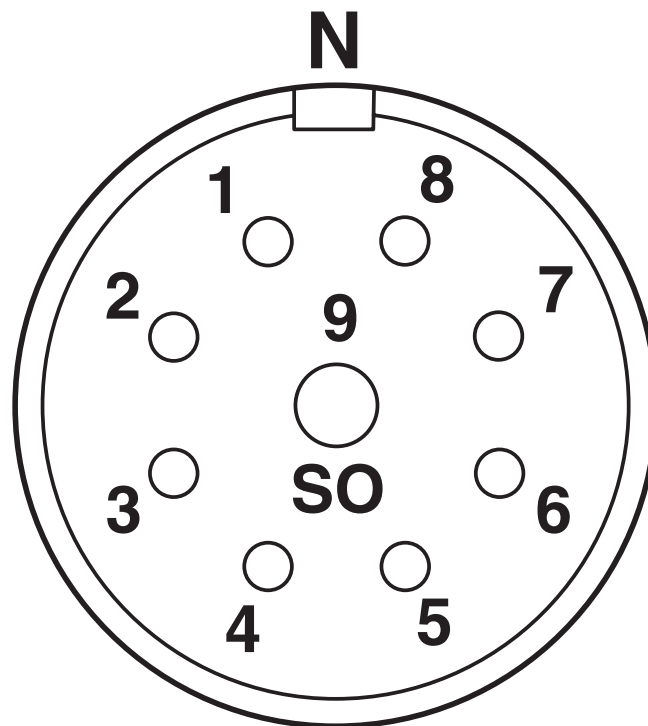

Schematic diagram



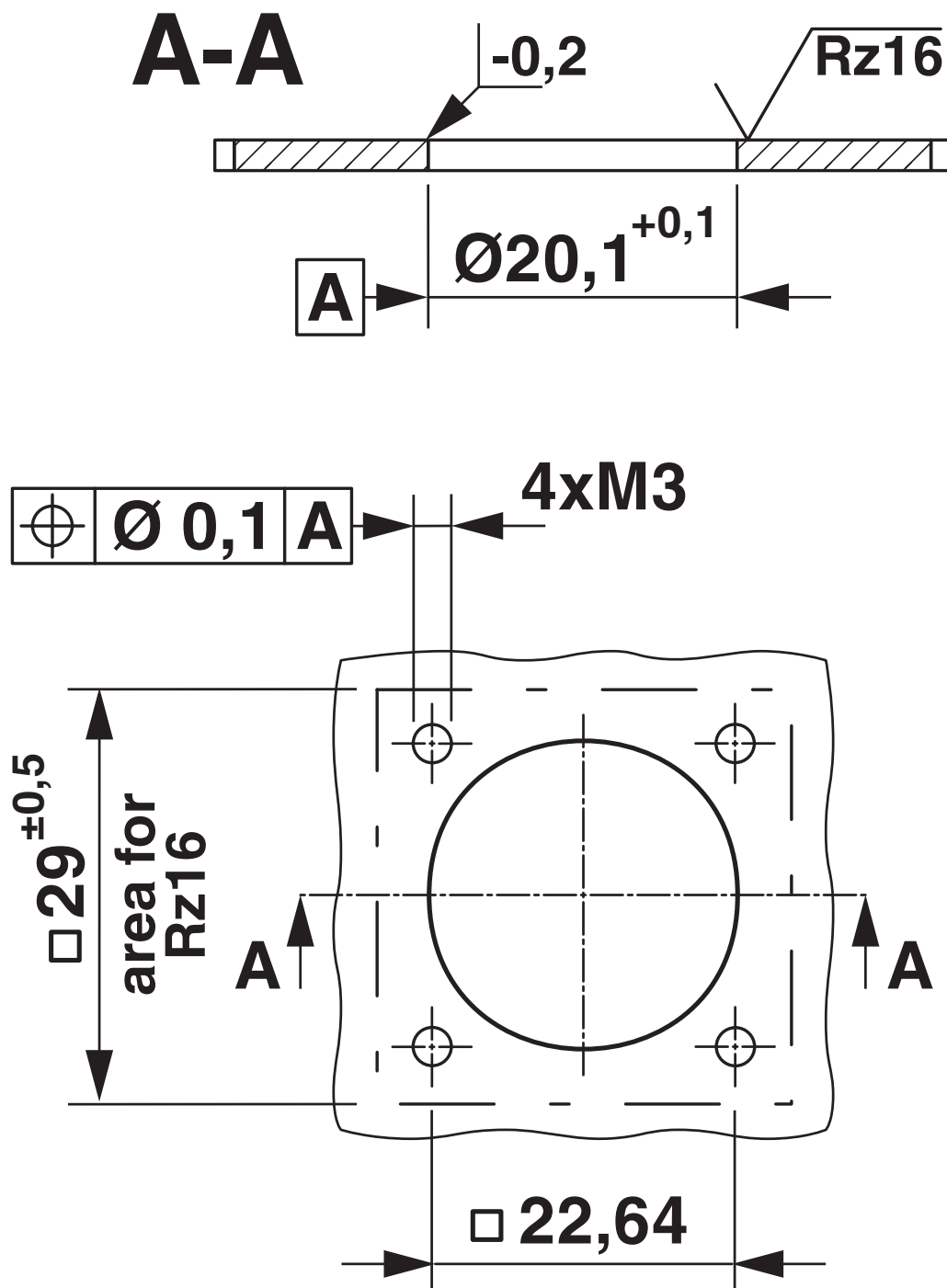
Connector pin assignment

Dimensional drawing



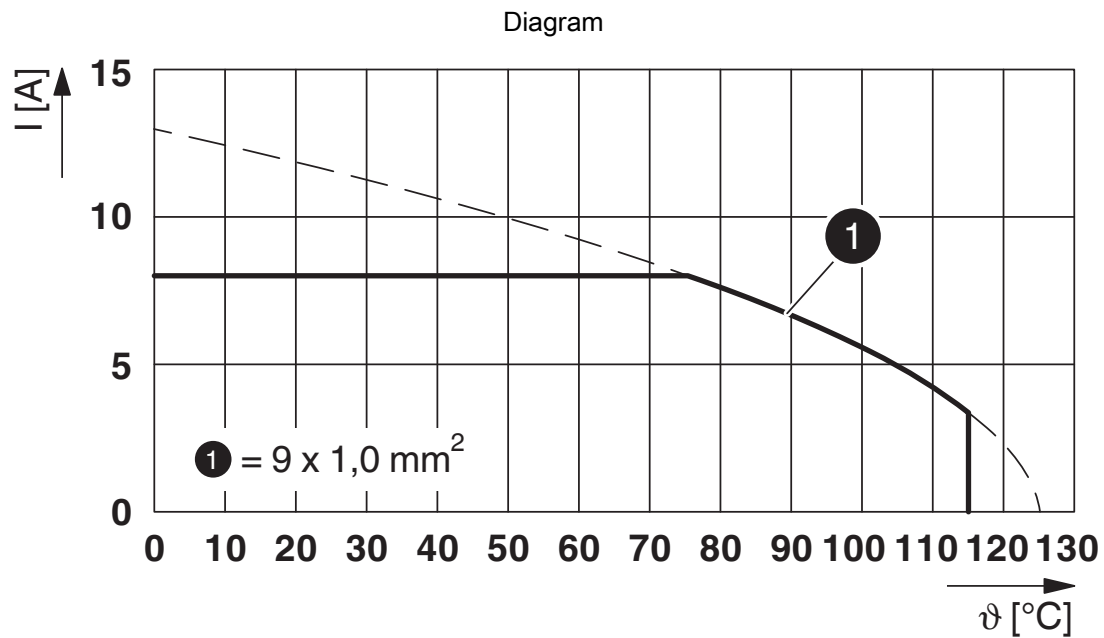
Installation dimensions
