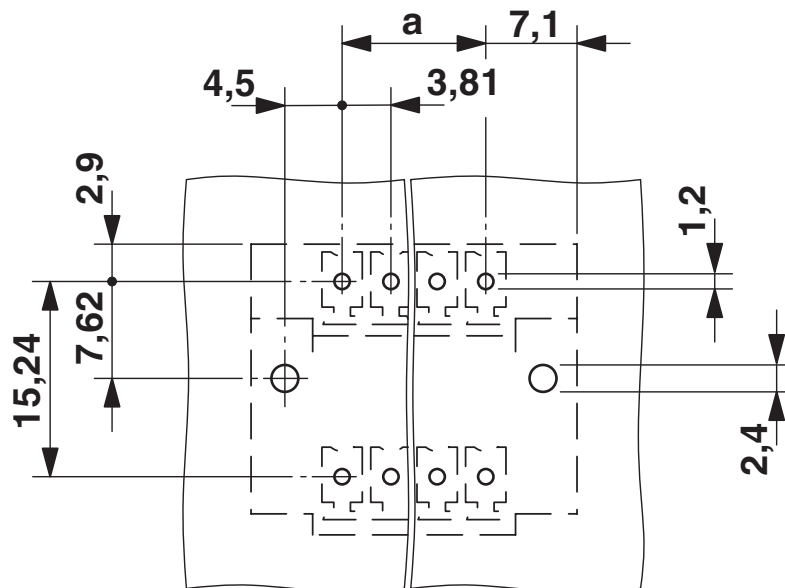

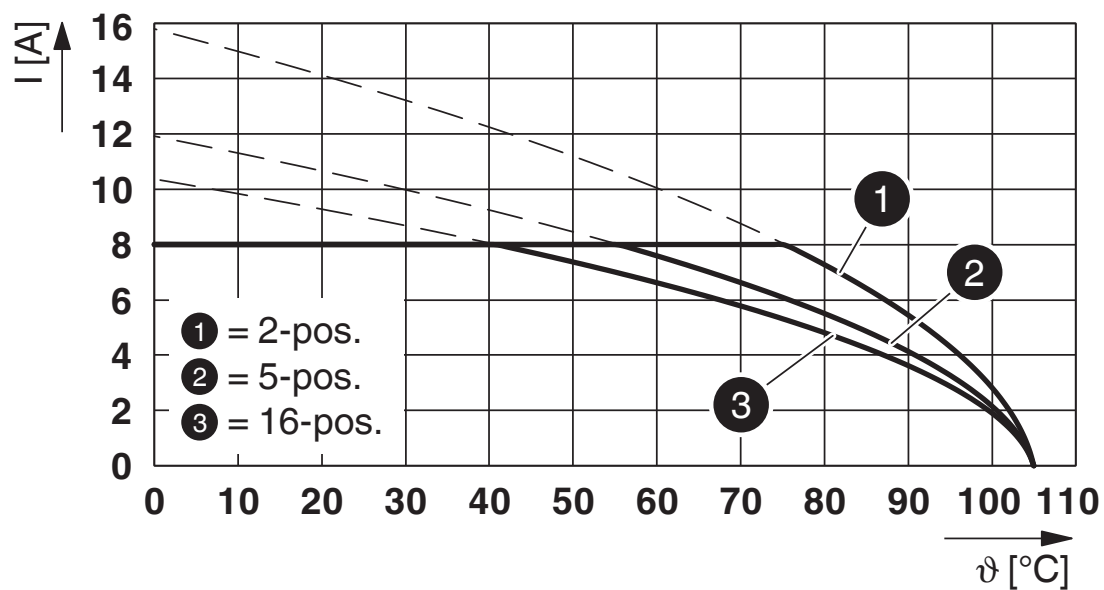


Type: MCVW 1,5/...-STF-3,81 with MCDV 1,5/...-GF-3,81

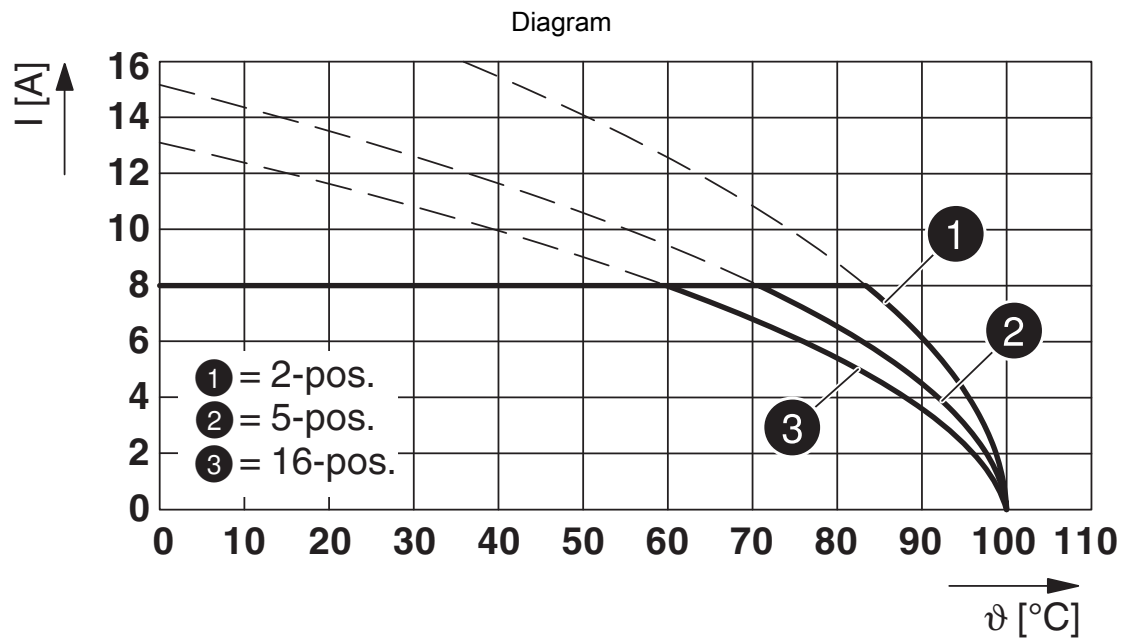
Drilling plan/solder pad geometry



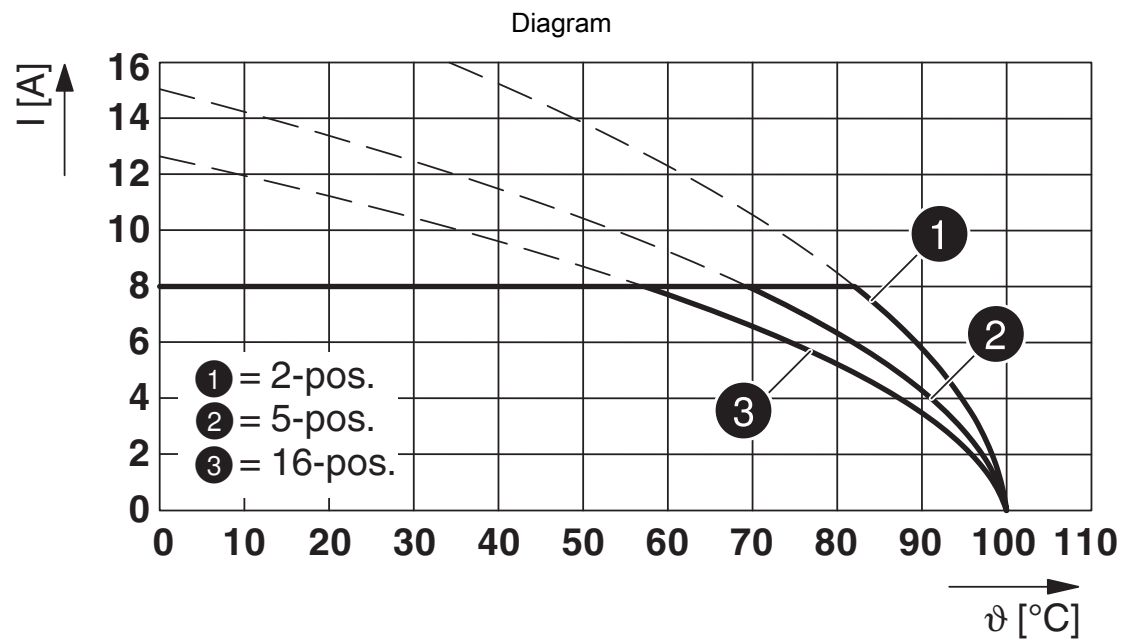

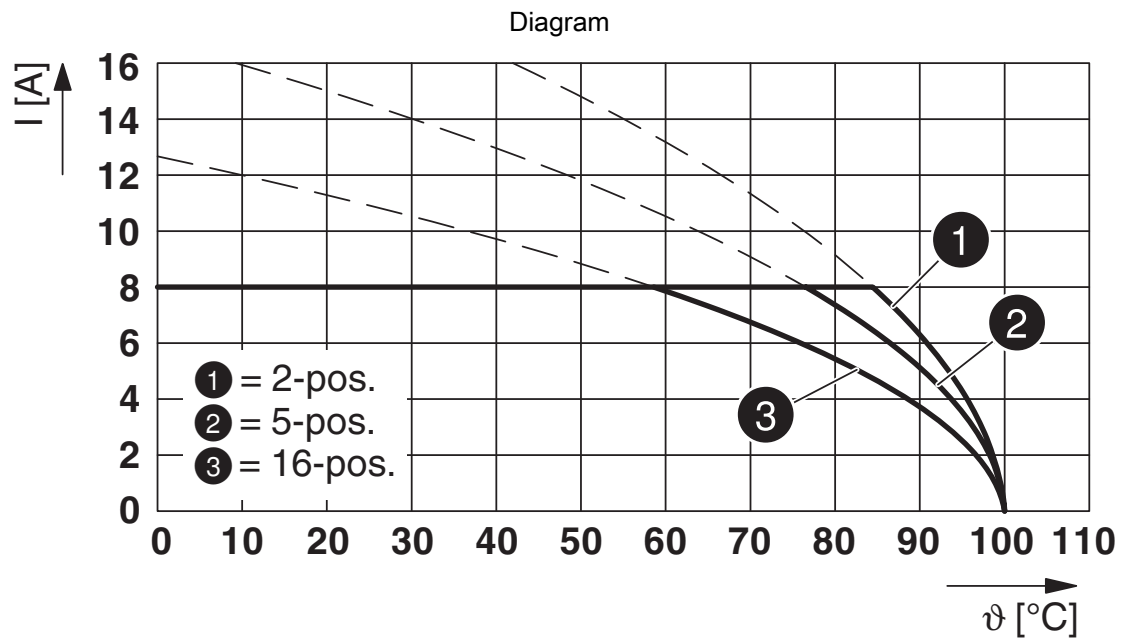
Type: MCVR 1,5/...-STF-3,81 with MCDV 1,5/...-GF-3,81

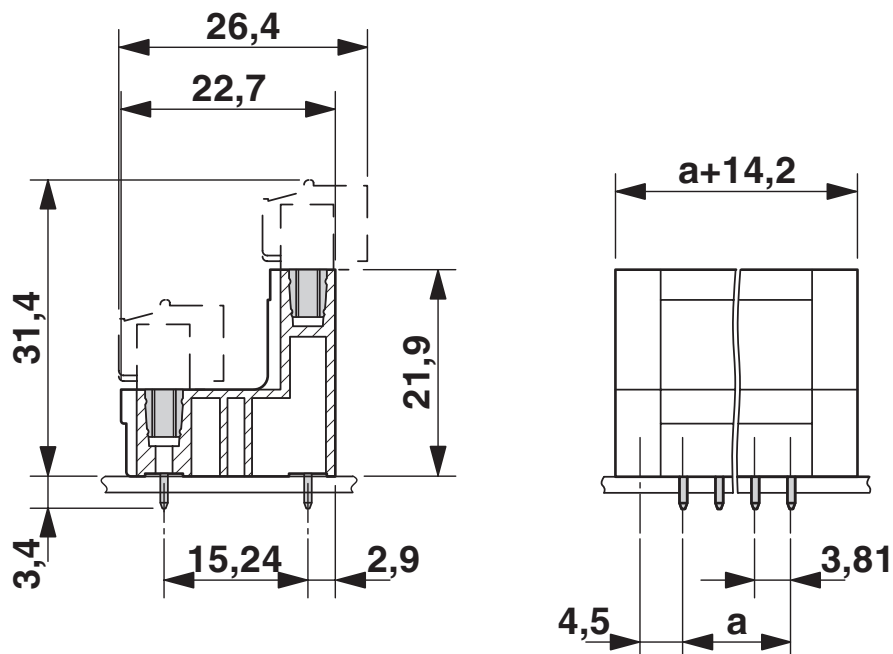


Type: FRONT-MC 1,5/...-STF-3,81 with MCDV 1,5/...-GF-3,81
