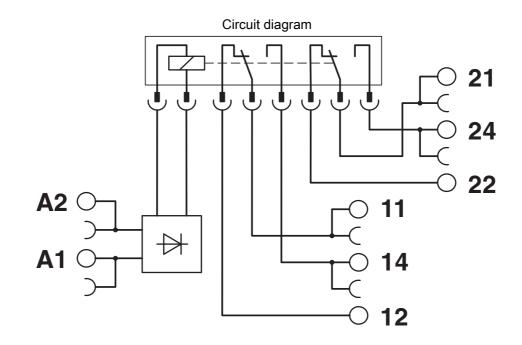

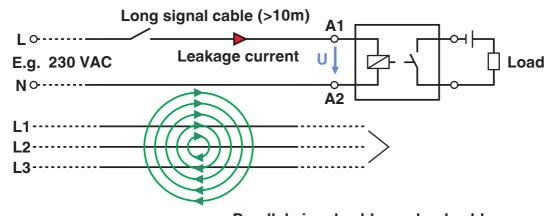

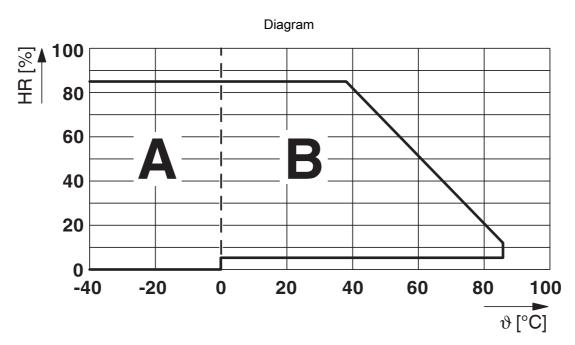
Parallel signal cables or load cables

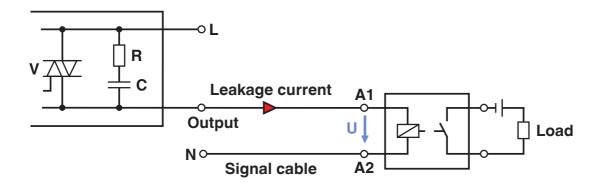
