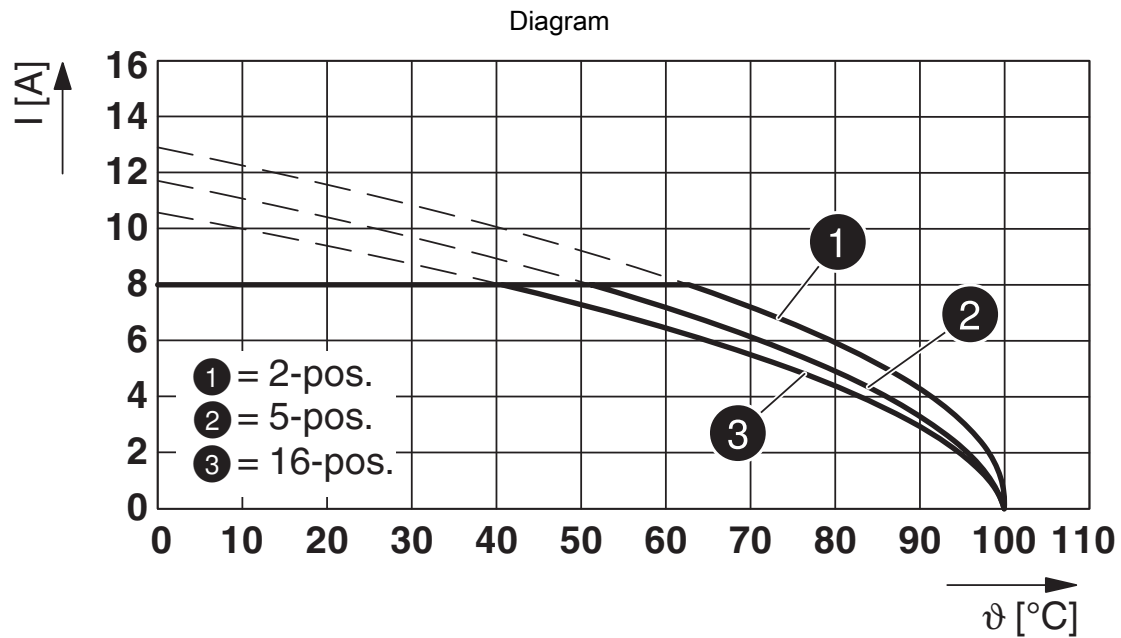

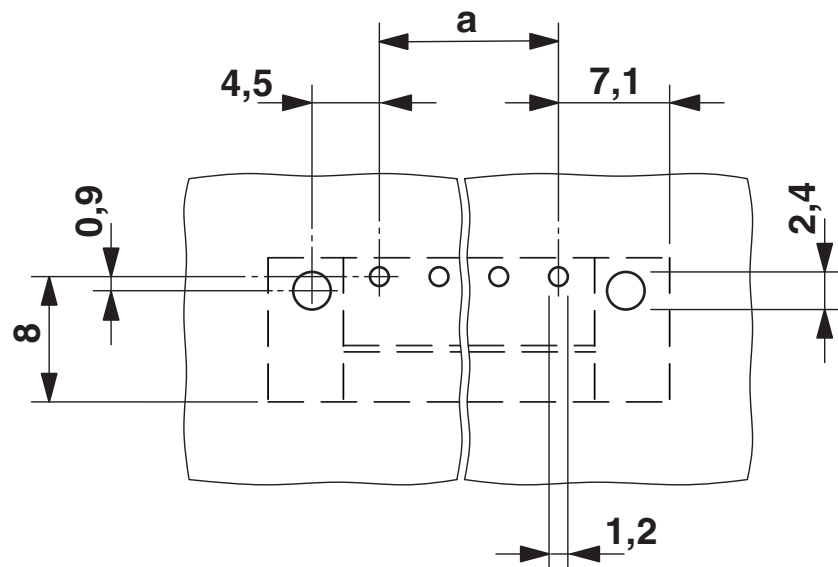

Drilling plan/solder pad geometry

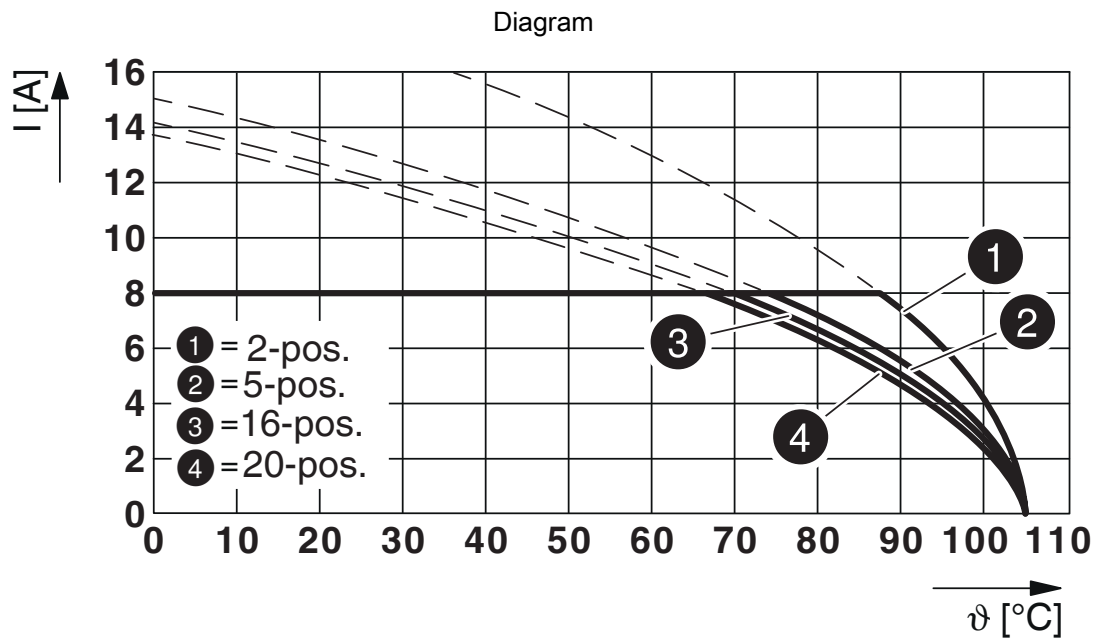

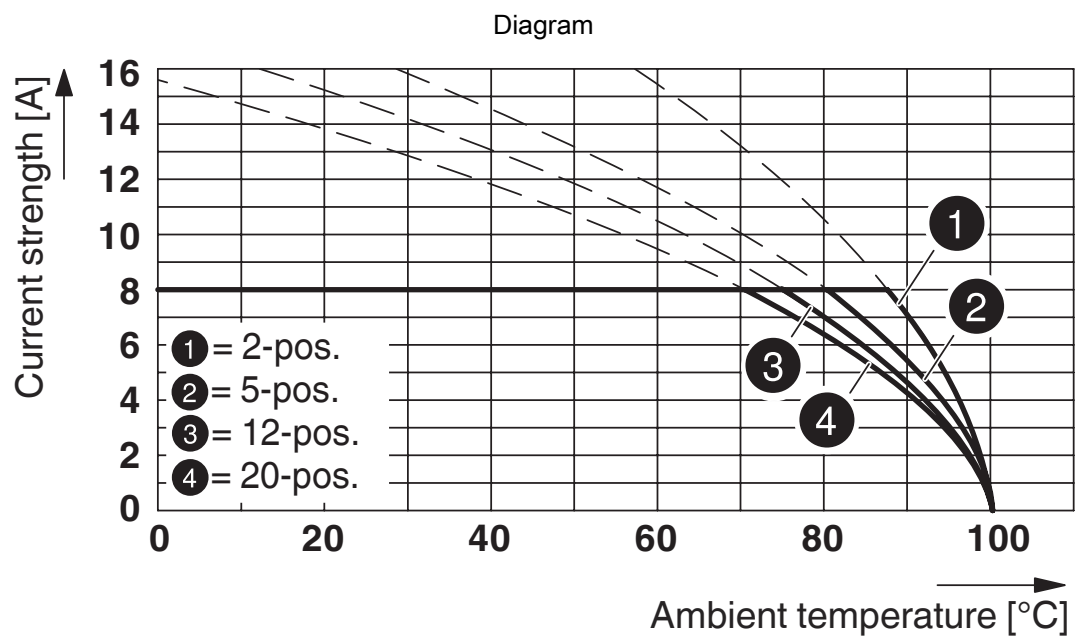

Type: FMC 1,5/...-STF-3,81 with MC 1,5/...-GF-3,81

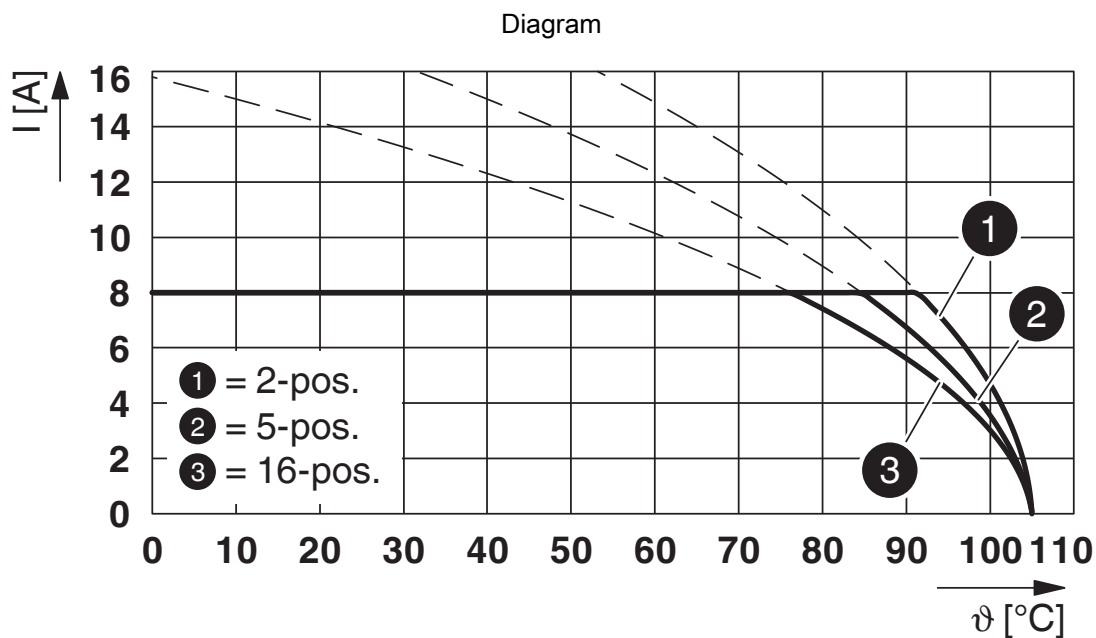

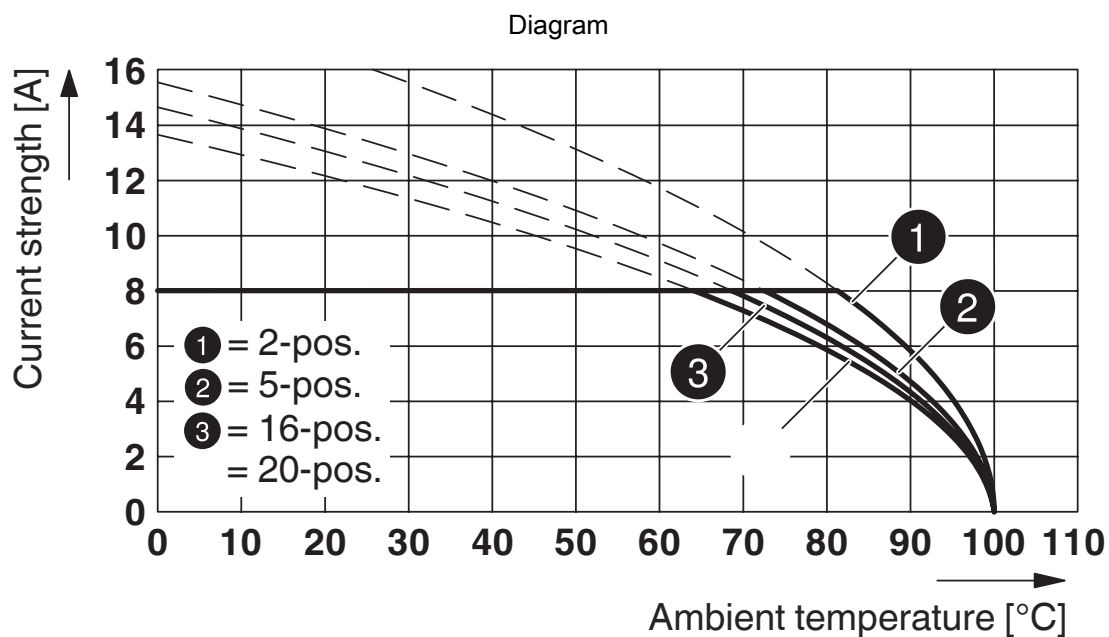

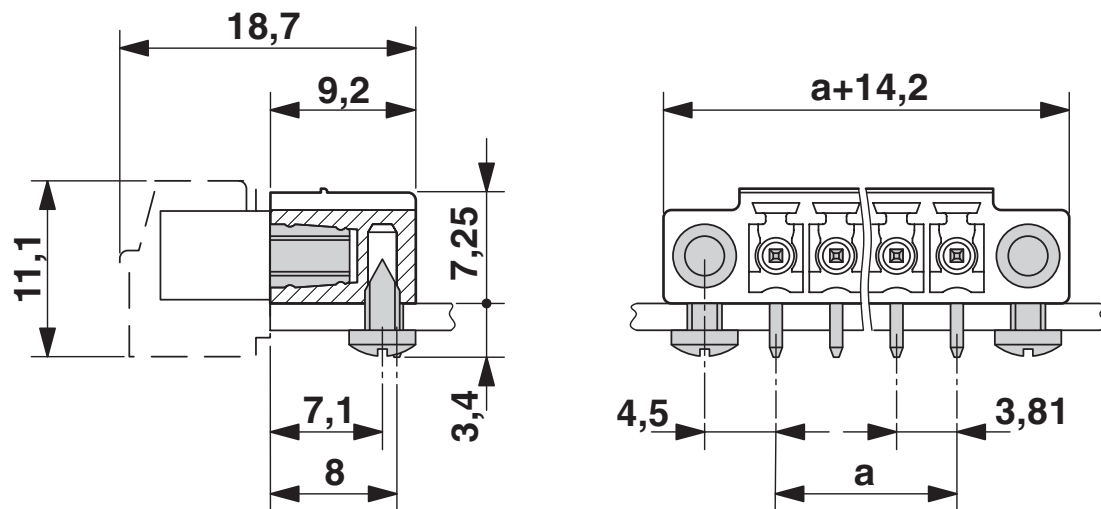

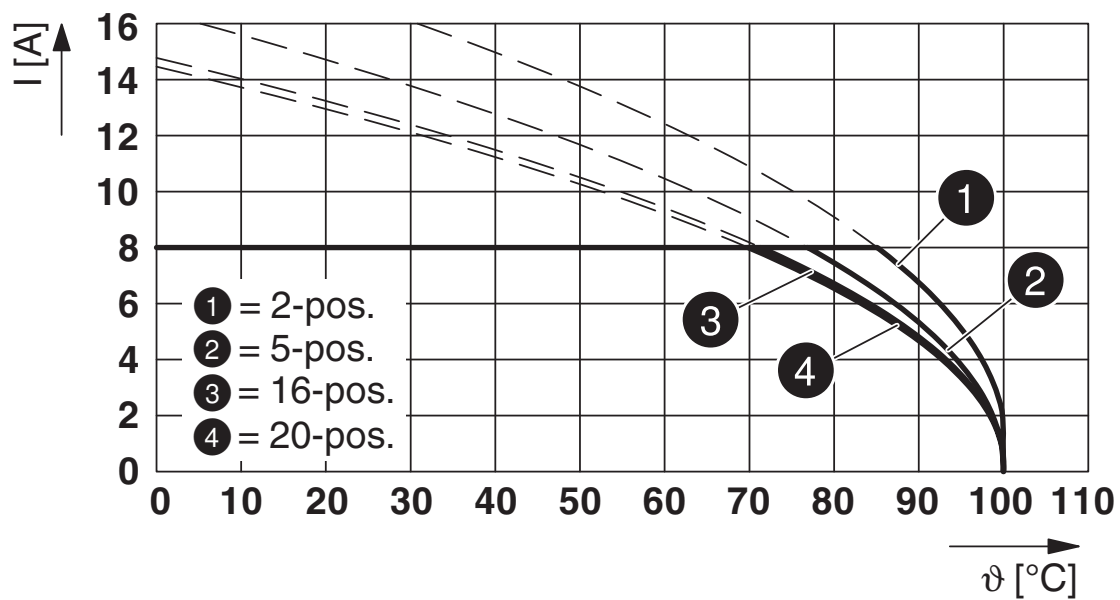
