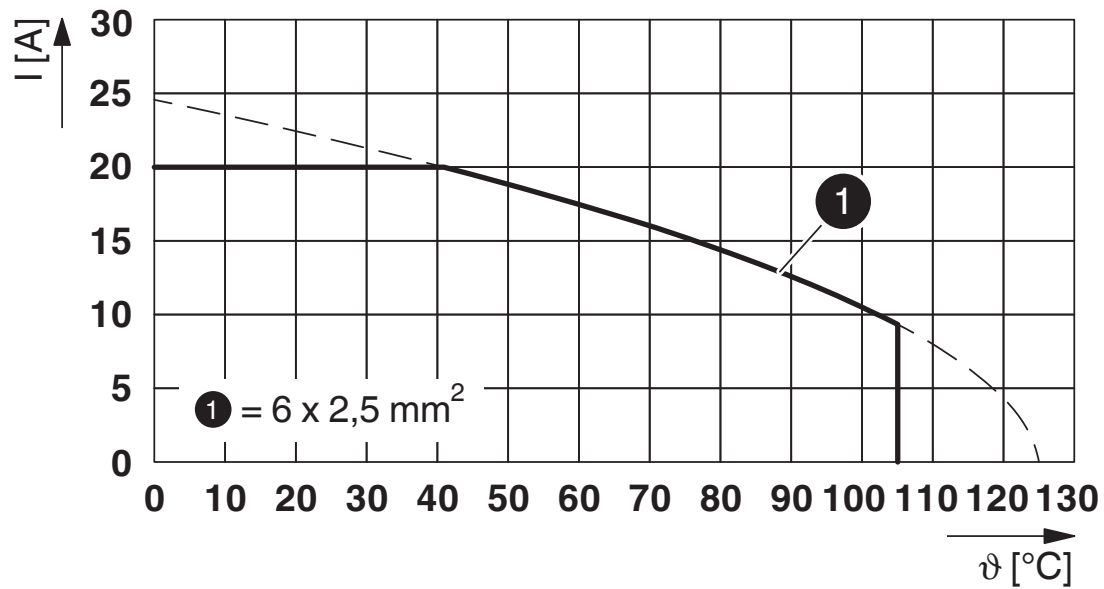

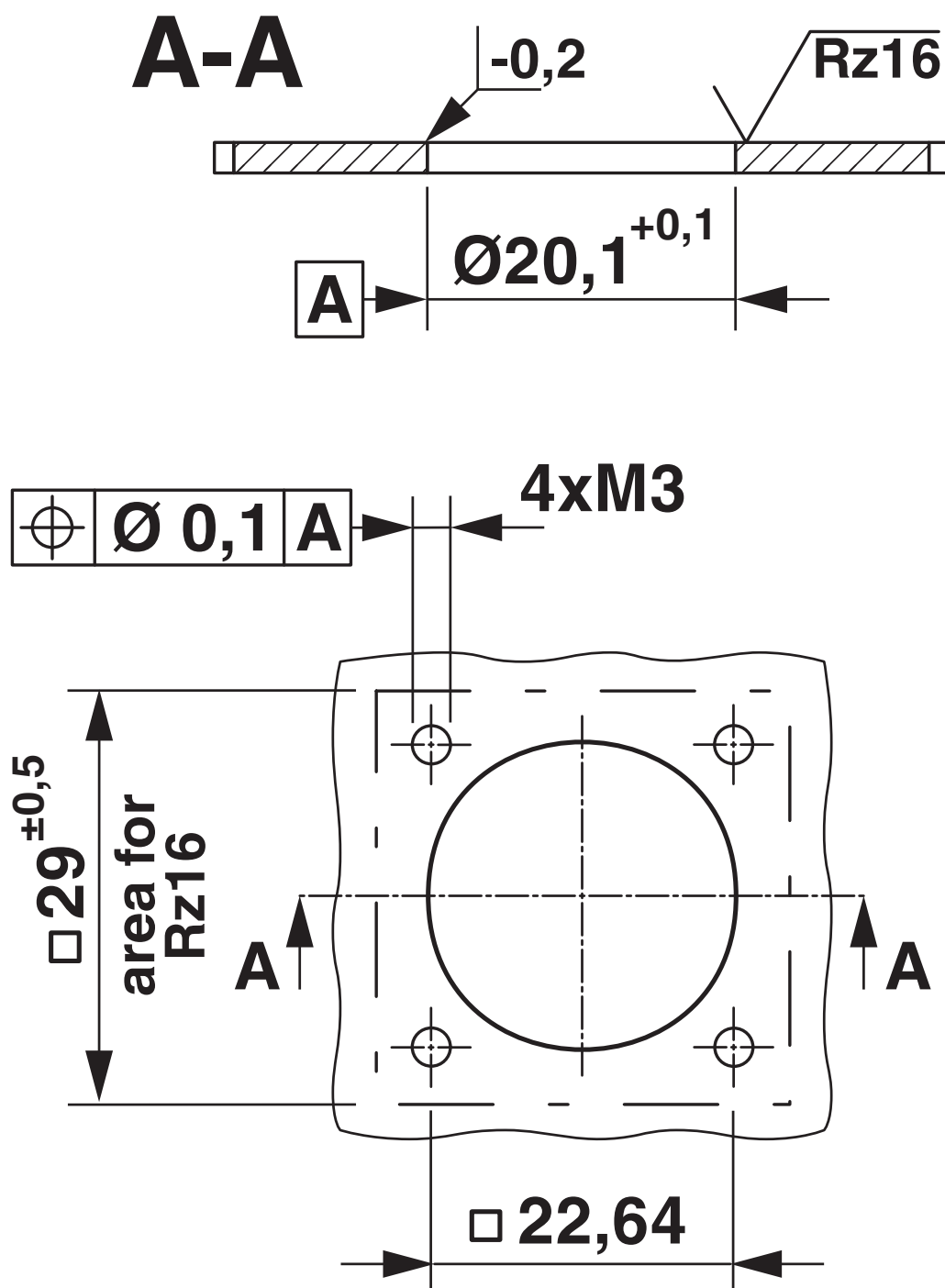

Dimensional drawing



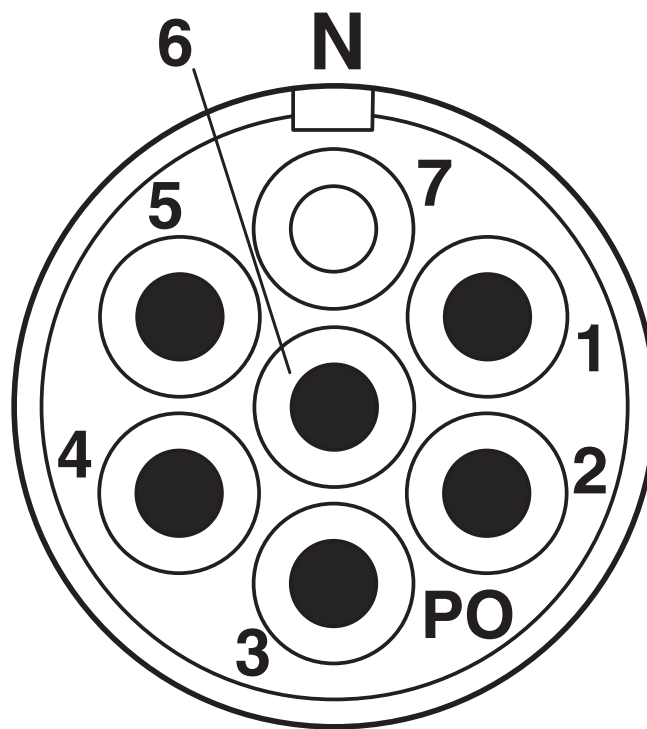
Installation dimensions
