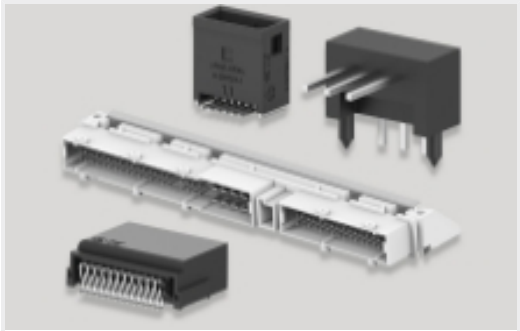
Backplane Connector Housings(19)

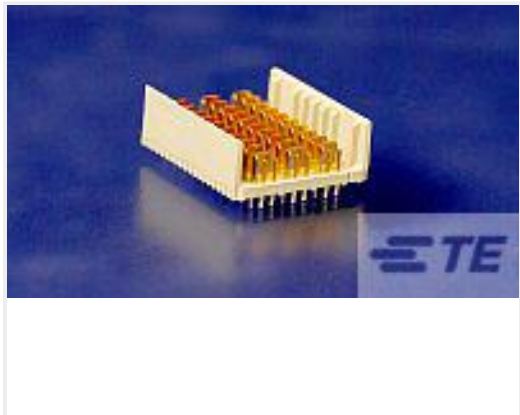

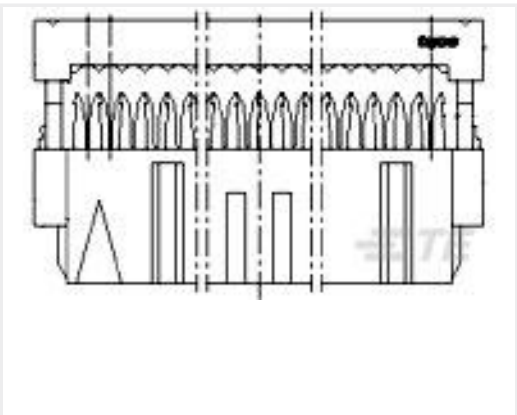
