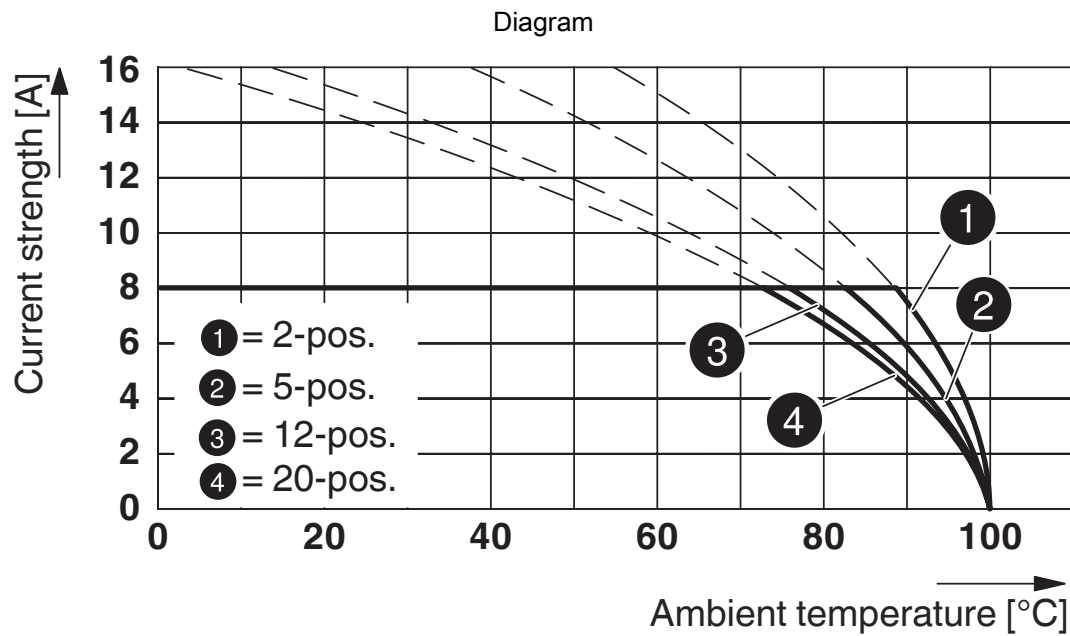


Type: FRONT-MC 1,5/...-STF-3,81 with MCV 1,5/...-GF-3,81

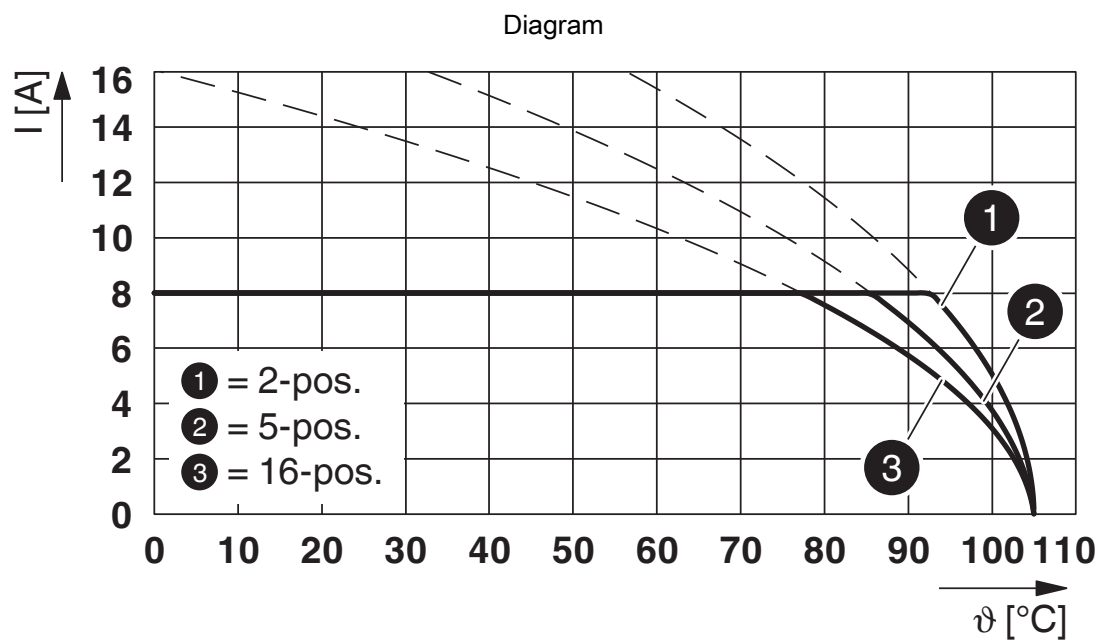

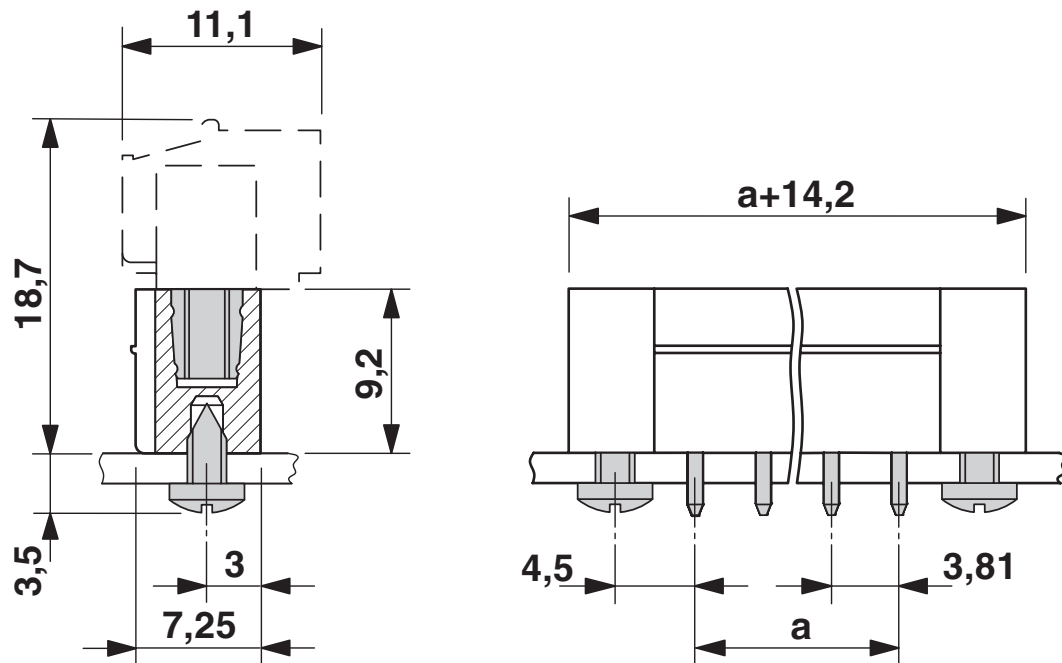

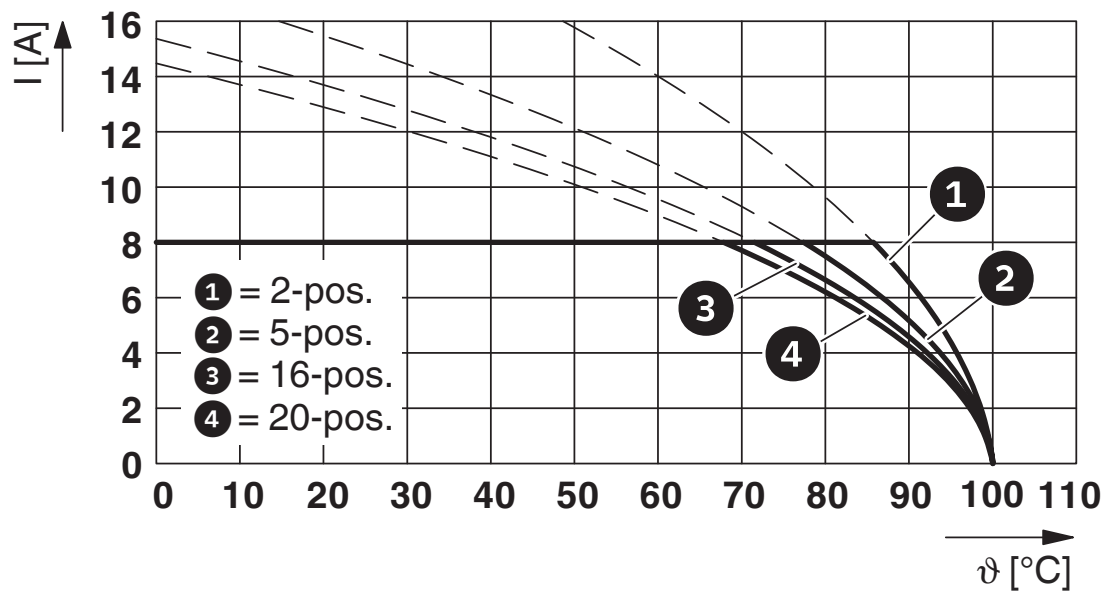
