





Matters needing attention

1、本公司产品适用于 AV 设备、OA 设备、家电、信息服务等一般电子设备中。

3、本承认书只保证我司产品作为一个单体时的质量情况, 当我司产品被安装到贵司产品上时, 请贵司对使用在贵司电路上的产品情况进行了有效评价和确认。

Our specification limits the quality of the component as a single unit. Please ensure the component is thoroughly evaluated in your application circuit.

4、不要对产品施加过大的振动或机械冲击;

Do not apply excessive vibration or mechanical shock to products.

5、为防止断线,请不要使用锋利的物体接触线圈,如镊子;

Do not touch wire with sharp objects such as tweezers to prevent wire breakage.

6、在产品贴装时不要使用过大的压力,避免磁芯断裂。

Do not apply excessive stress to products mounted on boards to prevent core breakage.

7、为保证端子电极的焊接特性和包装材料处于良好状态,请于本公司发货后6个月内使用本产品。同时,由于端子电极的焊接特性会随时间发生变化,如果贮存时间超过6个月,请首先确认其焊接特性后再安装使用。

To maintain the solderability of terminal electrodes and to keep the packing material in good condition, product should be used within 6 months from the time of delivery. And the solderability of products electrodes may decrease as time passes, so in case of storage over 6 months, solderability 8、存放货物的仓库应满足以下条件 Store products in a warehouse in compliance with the following condition:
