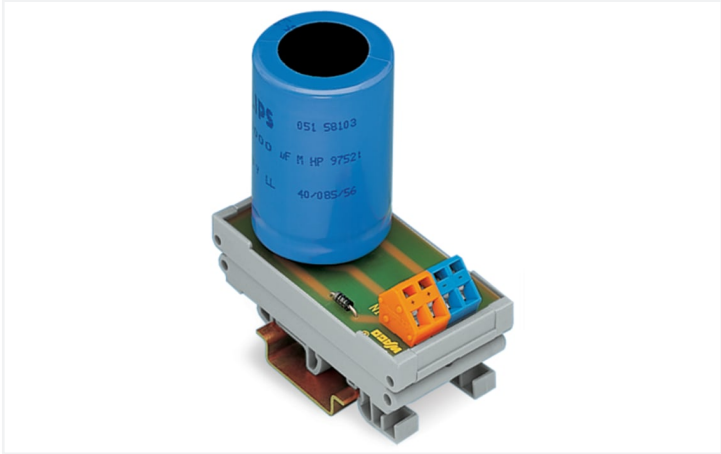
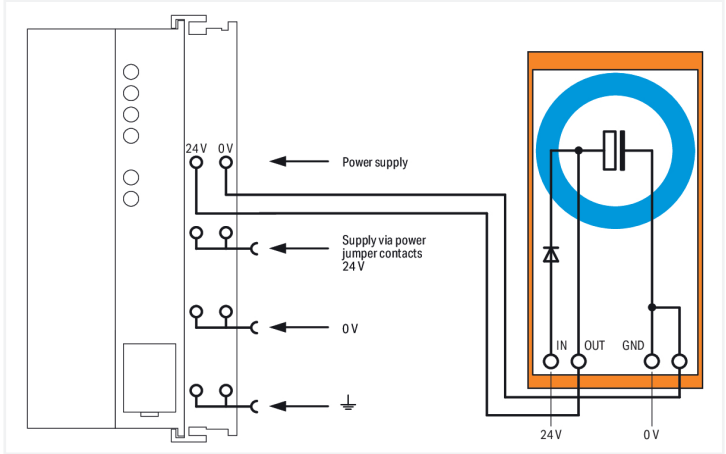

WAGO's back-up capacitor module smoothes unstable 24 VDC power supplies for electronic modules in case the voltage tolerances mentioned in our data sheets cannot be ensured. Reasons for voltage transients could be:

Features:

- Power interruptions (switching transients) on primary side
- Overloads on secondary side
- Switching of inductive or capacitive loads

The back-up capacitor module is connected between the 24 V power supply and the electronic device to be protected.
