


TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted












THERMAL RATINGS (T_A= 25 °C, unless otherwise noted)




Normalized Thermal Transient Impedance, Junction-to-Foot




- The characteristics shown in the two graphs


