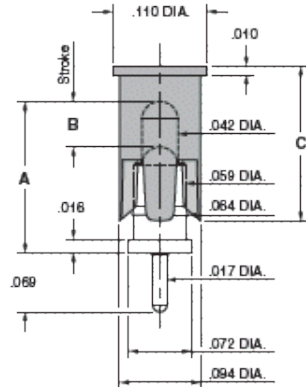




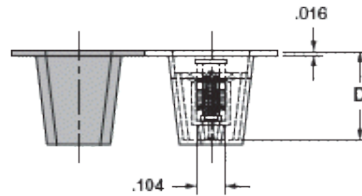

After machining, brass parts are often annealed (softened) for subsequent bending, swaging or crimping. A partial anneal down to 60 $\pm$ 10 RB is recommended for 90° bends, a full anneal down to 35 $\pm$ 15 RB is recommended for pins or terminals that are swaged (riveted) to a circuit board or crimped to a wire.
