
**Fig.1 - Typical Output Characteristics**




**Fig.2 - Transfer Characteristic**




**Fig.3 -  $R_{DS(ON)}$  -  $V_{GS}$**




**Fig.4 -  $R_{DS(ON)}$  -  $I_D$**

Fig.7 - Normalized Threshold Voltage




Fig.8 - Normalized On Resistance Characteristics




Fig.9 - I<sub>S</sub> - V<sub>SD</sub>




Fig.10 - Drain Current





Fig.11 - PD Dissipation

Fig.12 - Safe Operation Area





Fig.13 - Normalized Transient Thermal Impedance
